7 (a) Upon an organization's meeting the requirements in s.
8 320.08053, the Department of Highway Safety and Motor Vehicles
9 shall develop a NASCAR license plate as provided in this
10 subsection. The word "Florida" must appear at the top of the
11 plate. The NASCAR Hall of Fame, following consultation with
12 NASCAR and the International Speedway Corporation, may submit a
13 revised sample plate for consideration by the department.

14 (b) The annual use fee shall be distributed to the
15 Department of Revenue to offset the sales tax disbursements of

16 \$1.2 million per year by the Department of Revenue to the NASCAR
 17 Hall of Fame, Inc., for the construction, operation, and
 18 maintenance of the NASCAR Hall of Fame in Daytona Beach. Any
 19 distribution of fees to the department in excess of the sales
 20 tax distributions shall be retained and used to offset future
 21 distributions.

22 Section 6. The authorization of the specialty license
 23 plate as provided in this act is subject to the City of Daytona
 24 Beach's being designated as the site for the official NASCAR
 25 Hall of Fame. If that designation is not awarded to the City of
 26 Daytona Beach, the authorization of the NASCAR specialty tag is
 27 rescinded.

28 Section 7. Until the NASCAR Hall of Fame has been
 29 certified by the Office of Tourism, Trade, and Economic
 30 Development as provided in this act, the funds generated by the
 31 sale of the NASCAR license plate shall be deposited with the
 32 Department of Revenue and held in trust for the benefit of the
 33 NASCAR Hall of Fame facility upon certification. If the NASCAR
 34 Hall of Fame facility is not certified, the funds generated by
 35 the NASCAR license plate shall be used to support the sport of
 36 auto racing in this state.
