FULL ANALYSIS

I. SUBSTANTIVE ANALYSIS

A. HOUSE PRINCIPLES ANALYSIS:

This bill does not affect House Principles. The sections of law proposed for repeal are obsolete (for instance, the due date for a report has passed or the program is not operating) or outdated.

B. EFFECT OF PROPOSED CHANGES:

During the interim, staff of the Governor's Office of Policy and Budget (OPB) reviewed the Florida Statues for obsolete and outdated plans, reports, and programs. The OPB solicited recommendations from the executive agencies regarding possible repeal of certain statutes. Based on agency recommendations, OPB provided a draft bill to the House Governmental Operations Committee.

House Members, the Auditor General, the Office of Program Policy and Government Accountability, the Joint Administrative Procedures Committee staff, and all House staff reviewed and recommended action on the bill. Additionally, two private citizens provided comments.
