A community college may not charge any fee except as authorized 3 by law or rules of the State Board of Education. Parking fee revenues may be pledged by a community college board of 5 trustees as a dedicated revenue source for the repayment of 7 debt, including lease-purchase agreements and revenue bonds with terms not exceeding 20 years and not exceeding the useful 8 life of the asset being financed. Community colleges shall use the services of the Division of Bond Finance of the State 10 11 Board of Administration to issue any revenue bonds authorized by the provisions of this subsection.
