5 (11) A student, other than a nonimmigrant alien within the
6 meaning of 8 U.S.C. s. 1101(a)(15), who meets all of the
7 following requirements may apply for an exemption from paying
8 nonresident tuition at community colleges and state
9 universities:

10 (a) The student has resided in Florida with a parent, as
11 defined in paragraph (1)(f), for at least 3 consecutive years
12 immediately preceding the date the student received a high
13 school diploma or its equivalent and has attended a Florida high
14 school for at least 3 consecutive school years during such time.

15 (b) The student has registered and enrolled in a community
16 college or a state university. The student may apply for a term
17 deferral of any out-of-state fee assessed by the institution
18 until eligibility for the exemption is determined.

19 (c) The student has provided the community college or
20 state university an affidavit stating that the student will file
21 an application to become a permanent resident of the United
22 States at the earliest opportunity he or she is eligible to do
23 so.

24 (d) The student has submitted an application for the
25 exemption to the community college or state university in the
26 manner prescribed by the Department of Education.

27
28 The exemption authorized pursuant to this subsection shall be
29 limited to the top 2,000 students in academic performance in
30 Florida high schools who register and enroll at a community
31 college or state university under the exemption. The Department
32 of Education shall administer the exemption program and shall
33 develop an application form and guidelines for student
34 participation. The community college or state university shall
35 enter all application criteria submitted by the student into the
36 department's online database, in the manner and timeframe
37 prescribed by the department, for final determination by the
38 department of the student's eligibility to receive the
39 exemption.
