9	roles and responsibilities of the project participants.
10	5. A description of the processes and procedures that
11	will be used to identify and manage the project's risks and to
12	manage changes in the requirements of the project.

14	Upon approval of the operational work plan, the agency is
15	authorized to request the release of funds and positions
16	pursuant to chapter 216 and in a manner consistent with the
17	spending plan component of the operational work plan. Funds
18	or positions released for the information technology project
19	may not exceed the amount identified in the approved
20	operational work plan. Operational work plans shall be updated
21	as required in the General Appropriations Act.
22	(c) The agency shall submit to the chairs of the
23	legislative appropriations committees, and to the Executive
