#### **SUMMARY ANALYSIS**

The Supreme Court issued Order No. SC04-2154, dated November 30, 2004, certifying the need for 110 additional judges. HB 263 establishes 67 new circuit judges and 41 new county court judges for a total of 108 new judges.

Estimated annual recurring costs will be \$24.2 million. The new judges will be phased in during Fiscal Year 2005-06 at scheduled intervals. The estimated cost for Fiscal Year 2005-06 is \$12.38 million.

The House version of the General Appropriations Act authorizes General Revenue funds in the State Court System for both the circuit and county court judges and associated support staff.

## I. SUBSTANTIVE ANALYSIS

## B. EFFECT OF PROPOSED CHANGES:

The Supreme Court of Florida issued SC04-2154 on November 30, 2004 in regards to the Certification of Need for Additional Judges. In the certification, the court recommended 67 new circuit judges, 41 new county judges and 2 new appellate judges for a total of 110 new judges.

CS/HB 263 establishes 19 new circuit judges, effective October 1, 2005: 1 each in the First, Sixth, Seventh and Ninth Judicial Circuits; 2 each in the Fifth, Tenth, Eleventh, Thirteenth, Seventeenth and Nineteenth Judicial Circuits; and 3 in the Twentieth Judicial Circuit. Effective January 1, 2006, 23 new circuit judges are established: 1 each in the First, Second, Seventh, Eighth, Fourteenth, Fifteenth and Eighteenth Judicial Circuits; and 2 each in the Fifth, Sixth, Ninth, Tenth, Eleventh, Thirteenth, Seventeenth and Nineteenth Judicial Circuits. Effective April 1, 2006, 25 circuit judges will be added: 1 each in the First, Second and Eighteenth Judicial Circuits; 2 each in Sixth, Seventh, Ninth, Thirteenth and Seventeenth Judicial Circuits; and 3 each in the Fourth, Fifth, Tenth and Eleventh Judicial Circuits. There would be a total of 67 new circuit judges.

The bill establishes 21 new county court judges, effective January 1, 2006: 1 each in Collier, Miami-Dade, Marion, Palm Beach, Pasco, Bay, Columbia, Hernando, Lake, Lee, Manatee, Martin, St. Lucie, Seminole and Volusia Counties; 2 each in Orange, Brevard, Hillsborough and Pinellas Counties; and 3 in Broward County. Effective March 1, 2006, 20 new county court judges are established: 1 each in Collier, Miami-Dade, Marion, Orange, Palm Beach and Pasco Counties; 2 each in Brevard, Hillsborough, and Pinellas Counties; and 3 in Broward County. There would be a total of 41 new county judges.

There would be a total of 108 circuit and county judges. The bill does not establish any appellate judges.
