SUMMARY ANALYSIS

House bill 281 establishes a Paper Reduction Task Force to make recommendations to minimize the paperwork burden placed on school districts and school district personnel. The bill establishes the membership of the task force and requires a report to the legislature.

This act shall take effect upon becoming a law.

Substantive Impact

The Legislature will receive the task force recommendations to reduce paperwork requirements from the state level that burden districts and schools.

Fiscal Impact

The bill does not address the costs associated with task force travel, staffing, etc.; however, the costs appear to be insignificant.

FULL ANALYSIS

I. SUBSTANTIVE ANALYSIS

A. HOUSE PRINCIPLES ANALYSIS:

Provide limited government – The bill creates a task force and requires a report.

B. EFFECT OF PROPOSED CHANGES:

The bill creates an unnumbered section of law that establishes the Paper Reduction Task Force. The task force shall consist of the Commissioner of Education, three members appointed by the President of the Senate, three members appointed by the Speaker of the House of Representatives, three members appointed by the Governor, and three teachers appointed by the Commissioner of Education.

The task force will recommend strategies to reduce the paperwork required by the state of school districts and school district personnel, with special emphasis given to the reduction of paperwork required of teachers. The recommendations include but are not limited to eliminating, reducing. revising, or consolidating paperwork and data collection requirements. The members will also evaluate the need for information and determine whether access to necessary information is already available.

The task force shall report its findings and recommendations to the President of the Senate and the Speaker of the House of Representatives by February 1, 2006.

Current law (s. 1008.385 (2)(b)(1), F. S.) requires each school district to establish a reports system committee composed of school administrators and classroom teachers. "The committee shall periodically recommend procedures to the district school board for eliminating, reducing, revising, and consolidating paperwork and data collection requirements and shall submit to the district school board annual report of its findings." This statutory committee is focused on reducing paperwork generated by district requirements. The task force proposed in House bill 281 will focus on reduction of paperwork generated by state requirements.

Section 1: Unnumbered; creates the Paper Reduction Task Force.

Section 2: Establishes an effective date upon becoming law.
