13          Joseph O. Striska Florida Welcome Center in Hamilton  
14          County; designating Purple Heart Memorial Highway in  
15          Highlands County; repealing s. 25 of ch. 2004-392, Laws of

17          Petersburg/William C. Cramer Parkway in Pinellas County;  
18          designating St. Petersburg Parkway/William C. Cramer  
19          Memorial Highway in Pinellas County; designating Richard  
20          E. "Pete" Damon Bridge in Palm Beach County; designating  
21          Alexander Alden Ware Memorial Cable Barrier System in Palm  
22          Beach, St. Lucie, and Miami-Dade Counties; directing the  
23          Department of Transportation to erect suitable markers;  
24          designating Jorge L. Cabrera Way, Roi Henri Christophe  
25          Boulevard, Charles Summer Boulevard, Capois-La-Mort  
26          Boulevard, and Jean Baptiste Point du Sable Boulevard in  
27          Miami-Dade County; directing the Department of  
28          Transportation to erect suitable markers; designating Eric

29 Ulysses Ramirez Highway in Lake County; designating  
30 Trooper Darryl Haywood Highway; designating the David  
31 Hinson Parkway and the Charles W. Cherry Parkway in  
32 Volusia County; designating Teye Brown Parkway, Charles B.  
33 Dailey Parkway, and Johnnie Mae Chappell Parkway in Duval  
34 County; designating Dr. John M. Haile Memorial Boulevard  
35 in Marion County; designating Bob Graham/Sunshine Skyway  
36 Bridge in Pinellas County; designating Ricardo Karakadze  
37 Street in Miami-Dade County; directing the Department of  
38 Transportation to erect suitable markers; designating the  
39 Ralph C. Carter Parkway in Washington County; and  
40 designating the Henry Koerber Parkway in Walton County;  
41 and designating Fred N. Dunn, Sr. Highway in Orange  
42 County; directing the Department of Transportation to  
43 erect suitable markers; designating Art Pepin Boulevard in  
44 Hillsborough County; directing the Department of  
45 Transportation to erect suitable markers; providing an  
46 effective date.

48 Be It Enacted by the Legislature of the State of Florida:

49  
50 Section 1. Ramon Puig Way designated; Department of  
51 Transportation to erect suitable markers.--

52 (1) That portion of S.W. 8th Street between S.W. 62nd  
53 Avenue and S.W. 67th Avenue in Miami-Dade County is designated  
54 as "Ramon Puig Way."

55        (2) The Department of Transportation is directed to erect  
 56 suitable markers designating Ramon Puig Way as described in  
 57 subsection (1).

58        Section 2. Shawn O'Dare Way designated; Department of  
 59 Transportation to erect suitable markers.--

60        (1) That portion of N.W. 167th Street between N.W. 57th  
 61 Avenue and N.W. 67th Avenue in the Town of Miami Lakes in Miami-  
 62 Dade County is designated as "Shawn O'Dare Way."

63        (2) The Department of Transportation is directed to erect  
 64 suitable markers designating Shawn O'Dare Way as described in  
 65 subsection (1).

66        Section 3. Marge Pearlson Way designated; Department of  
 67 Transportation to erect suitable markers.--

68        (1) That portion of S.W. 129th Terrace between East 67th  
 69 Avenue and 64th Avenue in Miami-Dade County is designated as  
 70 "Marge Pearlson Way."

71        (2) The Department of Transportation is directed to erect  
 72 suitable markers designating Marge Pearlson Way as described in  
 73 subsection (1).

74        Section 4. Jorge L. Cabrera Way designated; Department of  
 75 Transportation to erect suitable markers.--

76        (1) That portion of Coral Way, S.W. 24th Street, between  
 77 107th Avenue and 109th Avenue in Miami-Dade County is designated  
 78 as "Jorge L. Cabrera Way."

79        (2) The Department of Transportation is directed to erect  
 80 suitable markers designating Jorge L. Cabrera Way as described  
 81 in subsection (1).

82           Section 5. Correction Officers Memorial Bridge designated;  
 83 Department of Transportation to erect suitable markers.--

84           (1) The New River Bridge on State Road 16 in Bradford and  
 85 Union Counties is designated as "Correction Officers Memorial  
 86 Bridge."

87           (2) The Department of Transportation is directed to erect  
 88 suitable markers designating Correction Officers Memorial Bridge  
 89 as described in subsection (1).

90           Section 6. Martin Andersen Beachline Expressway  
 91 designated; Department of Transportation to erect suitable  
 92 markers.--

93           (1) That portion of State Road 528 between its western  
 94 terminus in Orange County and its eastern terminus in Brevard  
 95 County, excluding that portion between U.S. Route 1 and State  
 96 Road 3, is designated as "Martin Andersen Beachline Expressway."

97           (2) The Department of Transportation is directed to erect  
 98 suitable markers designating Martin Andersen Beachline  
 99 Expressway as described in subsection (1).

100           (3) This section shall have no effect on chapter 98-423,  
 101 Laws of Florida, which designated that portion of State Road 528  
 102 between State Road 436 and State Road A1A as "Kennedy Space  
 103 Center Highway," and, therefore, the section of State Road 528  
 104 east of State Road 15 shall continue to have two names.

105           (4) That portion of State Road 528 between U.S. Route 1  
 106 and State Road 3 has been designated as "Emory Bennett Causeway"  
 107 and shall continue to have that designation notwithstanding this  
 108 section.

109           Section 7. Daniel Webster Western Beltway designated;  
 110 Department of Transportation to erect suitable markers.--

111           (1) That portion of State Road 429 between Interstate 4  
 112 and U.S. Highway 441 in Orange County is designated as "Daniel  
 113 Webster Western Beltway."

114           (2) The Department of Transportation is directed to erect  
 115 suitable markers designating Daniel Webster Western Beltway as  
 116 described in subsection (1).

117           Section 8. Robert F. Grim, Sr., Memorial Parkway  
 118 designated; Department of Transportation to erect suitable  
 119 markers.--

120           (1) That portion of Nova Road between Granada Boulevard  
 121 and U.S. Highway 1 in Volusia County is designated as "Robert F.  
 122 Grim, Sr., Memorial Parkway."

123           (2) The Department of Transportation is directed to erect  
 124 suitable markers designating Robert F. Grim, Sr., Memorial  
 125 Parkway as described in subsection (1).

126           Section 9. Veteran's Memorial Boulevard designated;  
 127 Department of Transportation to erect suitable markers.--

128           (1) That portion of U.S. Highway 331 from its intersection  
 129 with U.S. Highway 90 South to the southern border of the City of  
 130 DeFuniak Springs in Walton County is designated as "Veteran's  
 131 Memorial Boulevard."

132           (2) The Department of Transportation is directed to erect  
 133 suitable markers designating Veteran's Memorial Boulevard as  
 134 described in subsection (1).

135           Section 10. Southeastern Guide Dog Overpass designated;  
 136 Department of Transportation to erect suitable markers.--

137        (1) The overpass on 77th Avenue East, Bridge Number  
138 130090, over Interstate 275 in Manatee County is designated as  
139 "Southeastern Guide Dog Overpass."

140        (2) The Department of Transportation is directed to erect  
141 suitable markers designating Southeastern Guide Dog Overpass as  
142 described in subsection (1).

143        Section 11. Joseph O. Striska Florida Welcome Center  
144 designated; Department of Transportation to erect suitable  
145 markers.--

146        (1) The Florida Welcome Center on Interstate 75 at the  
147 Georgia state line in Hamilton County is designated as "Joseph  
148 O. Striska Florida Welcome Center."

149        (2) The Department of Transportation is directed to erect  
150 suitable markers designating Joseph O. Striska Florida Welcome  
151 Center as described in subsection (1).

152        Section 12. Purple Heart Memorial Highway designated;  
153 Department of Transportation to erect suitable markers.--

154        (1) That portion of U.S. Highway 27 that lies within  
155 Highlands County is designated as "Purple Heart Memorial  
156 Highway."

157        (2) The Department of Transportation is directed to erect  
158 suitable markers designating Purple Heart Memorial Highway as  
159 described in subsection (1).

160        Section 13. Section 25 of chapter 2004-392, Laws of  
161 Florida, is repealed.

162        Section 14. St. Petersburg Parkway/William C. Cramer  
163 Memorial Highway designated; Department of Transportation to  
164 erect suitable markers.--

165       (1) That portion of Interstate 275 in Pinellas County that  
 166 extends from the Howard Frankland Bridge to the Sunshine Skyway  
 167 Bridge is designated as "St. Petersburg Parkway/William C.  
 168 Cramer Memorial Highway."

169       (2) The Department of Transportation is directed to erect  
 170 suitable markers designating St. Petersburg Parkway/William C.  
 171 Cramer Memorial Highway as described in subsection (1).

172       Section 15. Richard E. "Pete" Damon Bridge designated;  
 173 Department of Transportation to erect suitable markers.--

174       (1) The bridge over the Loxahatchee River on State Road  
 175 Alternate A1A in the Town of Jupiter in Palm Beach County is  
 176 designated as "Richard E. 'Pete' Damon Bridge."

177       (2) The Department of Transportation is directed to erect  
 178 suitable markers designating Richard E. "Pete" Damon Bridge as  
 179 described in subsection (1).

180       Section 16. Alexander Alden Ware Memorial Cable Barrier  
 181 System designated; Department of Transportation to erect  
 182 suitable markers.--

183       (1) The cable barrier system along the Florida Turnpike in  
 184 Palm Beach, St. Lucie, and Miami-Dade Counties is designated as  
 185 "Alexander Alden Ware Memorial Cable Barrier System."

186       (2) The Department of Transportation is directed to erect  
 187 suitable markers designating Alexander Alden Ware Memorial Cable  
 188 Barrier System as described in subsection (1).

189       Section 17. Roi Henri Christophe Boulevard designated;  
 190 Department of Transportation to erect suitable markers.--

191 (1) That portion of State Road 916 on N.W. 135th Street  
 192 between N.W. 7th Avenue and N.E. 6th Avenue in Miami-Dade County  
 193 is designated as "Roi Henri Christophe Boulevard."

194 (2) The Department of Transportation is directed to erect  
 195 suitable markers designating Roi Henri Christophe Boulevard as  
 196 described in subsection (1).

197 Section 18. Charles Summer Boulevard designated;  
 198 Department of Transportation to erect suitable markers.--

199 (1) That portion of State Road 916 on N.W. 135th Street  
 200 between N.W. 17th Avenue and N.W. 7th Avenue in Miami-Dade  
 201 County is designated as "Charles Summer Boulevard."

202 (2) The Department of Transportation is directed to erect  
 203 suitable markers designating Charles Summer Boulevard as  
 204 described in subsection (1).

205 Section 19. Capois-La-Mort Boulevard designated;  
 206 Department of Transportation to erect suitable markers.--

207 (1) That portion of State Road 916 on N.E. 135th Street  
 208 between N.E. 6th Avenue and Biscayne Boulevard in Miami-Dade  
 209 County is designated as "Capois-La-Mort Boulevard."

210 (2) The Department of Transportation is directed to erect  
 211 suitable markers designating Capois-La-Mort Boulevard as  
 212 described in subsection (1).

213 Section 20. Jean Baptiste Point du Sable Boulevard  
 214 designated; Department of Transportation to erect suitable  
 215 markers.--

216 (1) That portion of State Road 934 on N.W. 79th Street  
 217 between Interstate 95 and N.E. 10th Avenue in Miami-Dade County  
 218 is designated as "Jean Baptiste Point du Sable Boulevard."



219       (2) The Department of Transportation is directed to erect  
 220 suitable markers designating Jean Baptiste Point du Sable  
 221 Boulevard as described in subsection (1).

222       Section 21. Eric Ulysses Ramirez Highway designated;  
 223 Department of Transportation to erect suitable markers.--

224       (1) The portion of State Road 50 in Lake County between  
 225 the community of Stuckey and the Mascotte city limits is  
 226 designated as the "Eric Ulysses Ramirez Highway."

227       (2) The Department of Transportation is directed to erect  
 228 suitable markers designating the Eric Ulysses Ramirez Highway as  
 229 described in subsection (1).

230       Section 22. Trooper Darryl Haywood Highway designated;  
 231 Department of Transportation to erect suitable markers.--

232       (1) That portion of Interstate Highway 4 in the vicinity  
 233 of mile marker 123 in Volusia County is designated as "Trooper  
 234 Darryl Haywood Highway."

235       (2) The Department of Transportation is directed to erect  
 236 suitable markers designating Trooper Darryl Haywood Highway as  
 237 described in subsection (1).

238       Section 23. David Hinson Parkway designated; Department of  
 239 Transportation to erect suitable markers.--

240       (1) That portion of Nova Road in Volusia County between  
 241 International Speedway Boulevard to George W. Ingram Boulevard  
 242 is designated as the "David Hinson Parkway."

243       (2) The Department of Transportation is directed to erect  
 244 suitable markers designating the David Hinson Parkway as  
 245 described in subsection (1).

246           Section 24. Charles W. Cherry, Sr., Parkway designated;  
 247 Department of Transportation to erect suitable markers.--

248           (1) That portion of International Speedway Boulevard  
 249 between Nova Road and Beach Street in Volusia County is  
 250 designated as "Charles W. Cherry, Sr., Parkway."

251           (2) The Department of Transportation is directed to erect  
 252 suitable markers designating Charles W. Cherry, Sr., Parkway as  
 253 described in subsection (1).

254           Section 25. Taye Brown Parkway designated; Department of  
 255 Transportation to erect suitable markers.--

256           (1) That portion of New Kings Road (U.S. 1) in Duval  
 257 County between the 2400 block and the 3700 block is designated  
 258 as "Taye Brown Parkway."

259           (2) The Department of Transportation is directed to erect  
 260 suitable markers designating Taye Brown Parkway as described in  
 261 subsection (1).

262           Section 26. Charles B. Dailey Parkway designated;  
 263 Department of Transportation to erect suitable markers.--

264           (1) That portion of the Haines Street Expressway between  
 265 Jessie Street and Eighth Street in Duval County is designated as  
 266 "Charles B. Dailey Parkway."

267           (2) The Department of Transportation is directed to erect  
 268 suitable markers designating Charles B. Dailey Parkway as  
 269 described in subsection (1).

270           Section 27. Johnnie Mae Chappell Parkway designated;  
 271 Department of Transportation to erect suitable markers.--

272       (1) That portion of U.S. Highway 1 between Finch Avenue  
 273 and Redpoll Avenue in Duval County is designated as "Johnnie Mae  
 274 Chappell Parkway."

275       (2) The Department of Transportation is directed to erect  
 276 suitable markers designating Johnnie Mae Chappell Parkway as  
 277 described in subsection (1).

278       Section 28. Dr. John M. Haile Memorial Boulevard  
 279 designated; Department of Transportation to erect suitable  
 280 markers.--

281       (1) That portion of East Silver Springs Boulevard, State  
 282 Road 40, in the City of Ocala from East 11th Avenue to East 16th  
 283 Avenue is designated as the "Dr. John M. Haile Memorial  
 284 Boulevard."

285       (2) The Department of Transportation is directed to erect  
 286 suitable markers designating the Dr. John M. Haile Memorial  
 287 Boulevard, as directed in subsection (1).

288       Section 29. Bob Graham/Sunshine Skyway Bridge designated;  
 289 Department of Transportation to erect suitable markers.--

290       (1) The Sunshine Skyway Bridge over Tampa Bay is  
 291 designated as the "Bob Graham/Sunshine Skyway Bridge."

292       (2) The Department of Transportation is directed to erect  
 293 suitable markers designating the Bob Graham/Sunshine Skyway  
 294 Bridge as described in subsection (1).

295       Section 30. Ricardo Karakadze Street designated;  
 296 Department of Transportation to erect suitable markers.--

297       (1) The portion of 104th Street between U.S. 1 and 97th  
 298 Avenue is designated as the "Ricardo Karakadze Street."

299       (2) The Department of Transportation is directed to erect  
 300 suitable markers designating the Ricardo Karakadze Street as  
 301 described in subsection (1).

302       Section 31. Ralph C. Carter Parkway designated; Department  
 303 of Transportation to erect suitable markers.--

304       (1) That portion of State Park Road at the entrance to the  
 305 Falling Waters State Recreational area, from Joiner Road to  
 306 Falling Waters Road, in Chipley, Washington County, is  
 307 designated as the "Ralph C. Carter Parkway."

308       (2) The Department of Transportation is directed to erect  
 309 suitable markers designating the Ralph C. Carter Parkway as  
 310 described in subsection (1).

311       Section 32. Henry Koerber Parkway designated; Department  
 312 of Transportation to erect suitable markers.--

313       (1) That portion of U.S. Highway 90, between Davis Lane  
 314 and Old Airport Road, in DeFuniak Springs, Walton County, is  
 315 designated as the "Henry Koerber Parkway."

316       (2) The Department of Transportation is directed to erect  
 317 suitable markers designating the Henry Koerber Parkway as  
 318 described in subsection (1).

319       Section 33. Fred N. Dunn, Sr. Highway designated;  
 320 Department of Transportation to erect suitable markers.--

321       (1) The portion of U.S. Highway 441 between Plymouth  
 322 Sorrento Road and State Road 436 in Orange County is designated  
 323 as the "Fred N. Dunn, Sr. Highway."

324       (2) The Department of Transportation is directed to erect  
 325 suitable markers designating the Fred N. Dunn, Sr. Highway as  
 326 described in subsection (1).

327           Section 34. Art Pepin Boulevard designated; Department of  
328 Transportation to erect suitable markers.--

329           (1) That portion of 56th Street between Fletcher Avenue  
330 and Dr. Martin Luther King Boulevard in Hillsborough County is  
331 designated as "Art Pepin Boulevard."

332           (2) The Department of Transportation is directed to erect  
333 suitable markers designating Art Pepin Boulevard as described in  
334 subsection (1).

335           Section 21. This act shall take effect July 1, 2005.
