The Committee on Judiciary (Campbell) recommended the following **amendment to amendment** (803342):

**Senate Amendment (with title amendment)**

On page 11, between lines 19 and 20,

insert: Section 8. Subsection (8) is added to section 948.09, Florida Statutes, to read:

948.09 Payment for cost of supervision and rehabilitation.--

(8)(a) Each person who is placed on probation, drug offender probation, community control, control release, provisional release supervision, addiction-recovery supervision, or conditional release supervision under chapter 944, chapter 945, chapter 948, or chapter 958, or in a pretrial intervention program shall simultaneously pay a separate and additional \$5-per-month fee to the department.

(b) The department shall remit on a quarterly basis to the clerk of court in whose county the person was held in a county detention facility, as ex officio custodian of the funds of the county, any funds collected pursuant to this

1 section, less the costs of administration. The department  
 2 shall collect and maintain an accounting of any such fees  
 3 assessed, any such fees paid by the offender, the cost of  
 4 administration, and the amount remitted to the clerk and shall  
 5 report annually such accounting to the county's board of  
 6 county commissioners whose county detention facility was used  
 7 to hold the violator.

8 (c) The clerk shall maintain the moneys remitted to it  
 9 in accordance with this section in a separate special revenue  
 10 account, invest the funds held on deposit pursuant to general  
 11 law, and disburse the funds at the direction of the board,  
 12 less the costs of administration, and the board may  
 13 appropriate the funds for the sole purpose of offsetting some  
 14 of the costs of housing felons in county detention facilities.  
 15 The clerk shall annually prepare an audit of this special  
 16 revenue account and deliver it to the board.

17 (d) This \$5-per-month fee shall end upon completion of  
 18 the department's supervision of any person who was placed on  
 19 probation, drug offender probation, community control, control  
 20 release, provisional release supervision, addiction-recovery  
 21 supervision, or conditional release supervision under chapter  
 22 944, chapter 945, chapter 947, chapter 948, or chapter 958, or  
 23 in a pretrial intervention program.

24 (e) Any person found to be in violation of probation,  
 25 drug offender probation, community control, control release,  
 26 provisional release supervision, addiction-recovery  
 27 supervision, or conditional release supervision under chapter  
 28 944, chapter 945, chapter 947, chapter 948, or chapter 958, or  
 29 a pretrial intervention program, whose oversight  
 30 responsibility was not transferred from a county detention  
 31 facility is not required to pay the \$5 fee in paragraph (a).

amending s. 948.09, F.S.; requiring that certain persons under the supervision of the Department of Corrections pay a nominal monthly fee to the department; requiring the department to remit collected funds to the clerk of court; requiring the department to collect and maintain an accounting of certain funds and to annually report such accounting to the board of county commissioners; requiring the clerk to maintain moneys collected in a separate special revenue account, invest the funds, and disburse the funds at the direction of the board of county commissioners; authorizing the board of county commissioners to appropriate the funds for offsetting the cost of incarcerating felons in county detention facilities; requiring the clerk to submit an annual audit to the board of commissioners; providing for termination of payment of the monthly nominal fee; providing that certain persons under the supervision of the department are not required to pay the monthly nominal fee under certain
