Section 1. Pine Tree Water Control District continuation and transfer.--The Pine Tree Water Control District, an independent special district created by a special act of the Legislature, shall become a dependent district of the Village of Wellington on the effective date of this act. All special acts

of the Pine Tree Water Control District shall become ordinances of the Village of Wellington on the effective date of this act.

- (1) The assets, liabilities, and written contracts of the Pine Tree Water Control District, including all rights, obligations, duties, and relationships now existing by law or agreement shall be unaffected and shall remain in full force and effect and shall be those of the district as a dependent district of the Village of Wellington. All rights, claims, actions, orders, and all contracts of the special district and all legal or administrative proceedings involving the district shall continue in full force and effect under the jurisdiction of the district as a dependent district of the Village of Wellington.
- (2) The terms of office of the members of the Board of Supervisors of the Pine Tree Water Control District shall terminate, and the members of the Village Council of the Village of Wellington shall assume the duties and responsibilities of the Board of Supervisors of the Pine Tree Water Control District.
- (3) To the extent not inconsistent with village ordinances, all resolutions and policies of the Pine Tree Water Control District shall remain in effect until amended, revised, or repealed by the village council.
- (4) Additional provisions which are necessary to effect this transition and to provide for the operation of the Pine Tree Water Control District as a dependent district of the village shall be adopted by ordinance.

Section 2. Referendum.--On or before December 1, 2006, the Pine Tree Water Control District shall call and the Supervisor of Elections of Palm Beach County shall conduct a referendum, in accordance with the provisions of law relating to elections currently in force, on the question of whether the Pine Tree Water Control District shall become a dependent district of the Village of Wellington.

Section 3. This act shall take effect only if a majority of those qualified electors of the Pine Tree Water Control District voting in a referendum held pursuant to this act approve the referendum question in section 2, except that this section and section 2 shall take effect upon becoming a law.
