1 (1) Upon all roadways of sufficient width, a vehicle 2 shall be driven upon the right half of the roadway, except as follows: 3 4 (a) When overtaking and passing another vehicle proceeding in the same direction under the rules governing 5 б such movement; 7 (b) When an obstruction exists making it necessary to drive to the left of the center of the highway; provided any 8 person so doing shall yield the right-of-way to all vehicles 9 traveling in the proper direction upon the unobstructed 10 portion of the highway within such distance as to constitute 11 12 an immediate hazard; 13 (c) Upon a roadway divided into three marked lanes for traffic under the rules applicable thereon; or 14 (d) Upon a roadway designated and signposted for 15 16 one-way traffic. 17 (2) Upon a two-lane roadway providing for two-way 18 movement of traffic, a vehicle all roadways, any vehicle proceeding at less than the normal speed of traffic at the 19 time and place and under the conditions then existing shall be 20 21 driven in the right-hand lane then available for traffic or as 22 close as practicable to the right-hand curb or edge of the 23 roadway except when overtaking and passing another vehicle proceeding in the same direction or when preparing for a left 2.4 turn at an intersection or into a private road or driveway. 25 (3) Upon any roadway having four or more lanes for 26 27 moving traffic and providing for two-way movement of traffic, 2.8 no vehicle shall be driven to the left of the centerline of the roadway, except when authorized by official traffic 29 control devices designating certain lanes to the left side of 30 the center of the roadway for use by traffic not otherwise 31

1 permitted to use such lanes, or except as permitted under 2 paragraph (1)(b). However, this subsection shall not be construed as prohibiting the crossing of the centerline in 3 making a left turn into or from an alley, private road, or 4 5 drivewav. б (a) Upon a four-lane highway, an interstate highway, 7 or a highway with fully controlled access, or the Florida 8 Intrastate Highway System, a vehicle may not be driven in the left-hand lane except when overtaking and passing another 9 10 vehicle. (b) Paragraph (a) shall not apply: 11 12 When no other vehicle is directly behind the 1. 13 vehicle in the left-hand lane; 2. When traffic conditions and congestion make it 14 impractical to drive in the right-hand lane; 15 3. When inclement weather conditions make it necessary 16 17 to drive in the left-hand lane; 18 4. When obstructions or hazards exist in the right-hand lane; 19 5. When, because of highway design, a vehicle must be 20 21 driven in the left-hand lane when preparing to exit; 22 6. On toll highways when necessary to use Sun-Pass and 23 on toll and other highways when driving in the left-hand lane is required to comply with an official traffic control device; 2.4 25 or 7. To law enforcement vehicles, ambulances, and other 26 27 emergency vehicles engaged in official duties and vehicles 2.8 engaged in highway maintenance and construction operations. (4) A violation of this section is a noncriminal 29 30 traffic infraction, punishable as a moving violation as provided in chapter 318. 31

Paragraph (d) of subsection (3) of section 2 322.27, Florida Statutes, is amended to read: 322.27 Authority of department to suspend or revoke 3 license.--4 5 (3) There is established a point system for evaluation 6 of convictions of violations of motor vehicle laws or 7 ordinances, and violations of applicable provisions of s. 8 403.413(6)(b) when such violations involve the use of motor vehicles, for the determination of the continuing 9 qualification of any person to operate a motor vehicle. The 10 department is authorized to suspend the license of any person 11 12 upon showing of its records or other good and sufficient 13 evidence that the licensee has been convicted of violation of motor vehicle laws or ordinances, or applicable provisions of 14 s. 403.413(6)(b), amounting to 12 or more points as determined 15 by the point system. The suspension shall be for a period of 16 17 not more than 1 year. (d) The point system shall have as its basic element a 18 graduated scale of points assigning relative values to 19 convictions of the following violations: 20 1. Reckless driving, willful and wanton--4 points. 21 22 2. Leaving the scene of a crash resulting in property 23 damage of more than \$50--6 points. 3. All other moving violations (including parking on a 1 2 highway outside the limits of a municipality)--3 points. 3 However, no points shall be imposed for a violation of s. 4 316.0741 or s. 316.2065(12). 5 7. Any moving violation covered above, excluding 6 unlawful speed, resulting in a crash--4 points. 7 8. Any conviction under s. 403.413(5)(b)--3 points. 8 9. Any conviction under s. 316.081--4 points. 9 Section 5. The Department of Highway Safety and Motor 10 Vehicles shall provide an educational awareness campaign 11 informing the motoring public about the Road Rage Reduction 12 Act. The department shall provide information about the Road 13 Rage Reduction Act in all newly printed driver license educational materials after October 1, 2005, and in public 14 service announcements produced in cooperation with the Florida 15 Highway Patrol. 16 17 Section 6.
