8 (5) ELIGIBILITY.--Eligibility to enroll in an approved  
9 health flex plan is limited to residents of this state who:

10 (a)1. Are 64 years of age or younger;

11 2.~~(b)~~ Have a family income equal to or less than 250 ~~200~~  
12 percent of the federal poverty level;

13 3.~~(e)~~ Are eligible under a federally approved Medicaid  
14 demonstration waiver and reside in Palm Beach County or Miami-  
15 Dade County;

 36        5. Has a workforce in which 75 percent of the employees  
 37 meet all the eligibility criteria in paragraph (a).
