# B. EFFECT OF PROPOSED CHANGES:

# **Present Situation:**

The President proposed in his 2005-2006 budget to Congress that the Navy's aircraft carrier fleet be reduced from twelve to eleven as part of the Department of Defense's overall cost saving strategy. Speculation by the media and many senior military officials is that the U.S.S. John F. Kennedy (USS Kennedy) aircraft carrier, the navy's last Atlantic-based fossil-fueled carrier, based in Mayport Naval Station. Florida, is the carrier that will be decommissioned.

An environmental study to determine if Mayport can be converted to a port for a nuclear-fueled aircraft carrier was included in the budget proposal. This is seen by many as a prelude to possibly moving one of the nuclear-fueled carriers currently based in Virginia southward to Mayport.

The USS Kennedy recently underwent an overhaul with a cost of \$350 million and is scheduled to go through another overhaul of \$350 million later this year, should the carrier not be decommissioned. The carrier is manned and supported by 5,000 sailors, and the economic impact of losing them and their families would be a loss of \$200 million<sup>1</sup> to the Jacksonville economy.

Legislation has been introduced to the U.S. House that would maintain the aircraft carrier fleet strength at twelve. In addition, Congress is currently developing their version of the budget.

# **Effect of Proposed Changes:**

This memorial urges Congress to oppose the decommissioning of the USS Kennedy from active service. This memorial also urges Congress to allow Mayport Naval Station to remain the homeport of USS Kennedy until Mayport is able to support and serve as home port for a nuclear-fueled aircraft carrier. Finally, the memorial urges Congress to maintain the U.S. Navy's Atlantic aircraft carrier fleet at its current strength.
