## A bill to be entitled

An act relating to regional autism centers; amending s. 1004.55, F.S.; creating an additional regional autism center in the state; reducing the number of counties within the service areas of two existing regional autism centers; providing for consistency in service delivery; encouraging each constituency board to raise funds; providing a prohibition; providing an effective date.

10 Be It Enacted by the Legislature of the State of Florida:

Section 1. Subsections (1) through (4) of section 1004.55,Florida Statutes, are amended to read:

1004.55 Regional autism centers.--

15 Seven Six regional autism centers are established to (1)provide nonresidential resource and training services for 16 persons of all ages and of all levels of intellectual 17 functioning who have autism, as defined in s. 393.063; who have 18 a pervasive developmental disorder that is not otherwise 19 specified; who have an autistic-like disability; who have a dual 20 21 sensory impairment; or who have a sensory impairment with other 22 handicapping conditions. Each center shall be operationally and 23 fiscally independent and shall provide services within its geographical region of the state. Service delivery shall be 24 consistent for all centers. Each center shall coordinate 25 services within and between state and local agencies and school 26 27 districts but may not duplicate services provided by those

28 agencies or school districts. The respective locations and 29 service areas of the centers are:

56 (2)There is established for each center a constituency board, which shall work collaboratively with the center. Each 57 board shall consist of no fewer than six members, each of whom 58 is either an individual who has a disability that is described 59 in subsection (1) or is a member of a family that includes a 60 person who has such a disability, who are selected by each 61 university president from a list that has been developed by the 62 Autism Society of Florida and other relevant constituency groups 63 that represent persons who have sensory impairments as described 64 in subsection (1). As representatives of the center's 65 66 constituencies, these boards shall meet quarterly with the staff 67 of each of the centers to provide advice on policies, priorities, and activities. Each board shall submit to the 68 university president and to the Department of Education an 69 annual report that evaluates the activities and accomplishments 70 of its center during the year. The board for each center should 71 raise funds equivalent to 2 percent of the total funds allocated 72 to that center in each fiscal year. 73

74 (3) To promote statewide planning and coordination, a 75 conference must be held annually for staff from each of the 76 <u>seven five</u> centers and representatives from each center's 77 constituency board. The purpose of the conference is to 78 facilitate coordination, networking, cross-training, and 79 feedback among the staffs and constituency boards of the 80 centers.

(4)(a) Each center shall provide:

82 <u>1.(a)</u> A staff that has expertise in autism and autistic83 like behaviors and in sensory impairments.

84	<u>2.(b)</u> Individual and direct family assistance in the home,
85	community, and school. A center's assistance should not supplant
86	other responsibilities of state and local agencies, and each
87	school district is responsible for providing an appropriate
88	education program for clients of a center who are school age.
89	<u>3.(c)</u> Technical assistance and consultation services,
90	including specific intervention and assistance for a client of
91	the center, the client's family, and the school district, and
92	any other services that are appropriate.
93	<u>4.(d)</u> Professional training programs that include
94	developing, providing, and evaluating preservice and inservice
95	training in state-of-the-art practices for personnel who work
96	with the populations served by the centers and their families.
97	5.(e) Public education programs to increase awareness of
98	the public about autism, autistic-related disabilities of
99	communication and behavior, dual sensory impairments, and
100	sensory impairments with other handicapping conditions.
101	(b) Direct medical intervention or pharmaceutical
102	intervention is prohibited in any center on or after July 1,
103	2008.
