Subsection (18) is added to section 212.08, Florida Statutes, to read: 14 212.08 Sales, rental, use, consumption, distribution, 15 and storage tax; specified exemptions. -- The sale at retail, 16 17 the rental, the use, the consumption, the distribution, and the storage to be used or consumed in this state of the 18 following are hereby specifically exempt from the tax imposed 19 by this chapter. 20 21 (18) PARTIAL EXEMPTION; HYBRID MOTOR VEHICLES. -- Hybrid motor vehicles eligible for tax credits under the federal 22 23 Energy Policy Act of 2005 are exempt from the first \$500 of tax imposed by this chapter. 2.4 Section 2. Subsection (4) of section 316.0741, Florida 25 Statutes, is amended to read: 26 27 316.0741 High occupancy vehicle lanes.--2.8 (4) Notwithstanding any other provision of this section, an inherently low-emission vehicle (ILEV) that is 29 certified and labeled in accordance with federal regulations 30 may be driven in an HOV lane at any time, regardless of its 31

In addition, upon the state's receipt of written 2 notice from the proper federal regulatory agency authorizing such use, a vehicle defined as a hybrid vehicle under this 3 section may be driven in an HOV lane at any time, regardless 4 5 of its occupancy. The department shall issue a decal and 6 registration certificate, to be renewed annually, reflecting 7 the HOV lane designation on such vehicles authorizing such 8 use. The department may charge a fee for a decal, not to 9 exceed the costs of designing, producing, and distributing 10 each decal, or \$5, whichever is less. The proceeds from sale of the decals shall be deposited in the Highway Safety 11 12 Operating Trust Fund. The department shall add to the list of 13 vehicles eligible to travel in HOV lanes any vehicle with a federal Environmental Protection Agency highway rating of more 14 than 40 miles per gallon but may remove some or all of such 15 vehicles from the list if, in the department's discretion, 16 17 congestion results in defeating the goal of greater fuel 18 economy. Under such circumstances, the department shall remove from the list the most fuel economical vehicles last. 19 20 Section 3. This act shall take effect upon becoming a 21 law. 22 23 SENATE SUMMARY 2.4 25 Provides a sales-tax exemption of \$500 for the purchase of a hybrid motor vehicle. Provides for a motor vehicle having a fuel-efficency rating of greater than 40 miles 26 per gallon to occupy the high occupancy vehicle lane 27 regardless of the number of occupants in the vehicle. 2.8 29 30 31 2
