20 Section 1. Subsections (2) and (7) of section 1002.23,
21 Florida Statutes, are amended to read:

24 (2) To facilitate meaningful parent and family

26 guidelines for a parent guide to successful student achievement

31 | (a) Parental information regarding:

34 | 2. Progress of their child toward achieving state and
35 | district expectations for academic proficiency;

36 | 3. Assessment results, including report cards and progress

38 | 4. Qualifications of their child's teachers; and

40 | immunizations and the recommended immunization schedule;

 88 and transmission of meningococcal disease and the availability,

 97 student conduct that is required in s. 1006.07(2).
