Senate Amendment (with title amendment)

On page 12, between lines 24 and 25,

insert:

Section 8. The Division of Health Access and Tobacco of the Department of Health shall analyze the supply and distribution of Florida-licensed dentists in Medicaid Services areas one and two of the Agency for Health Care Administration using data that are available from public and private sources. The division shall determine whether such dentists are retired or working full-time. The division shall submit a preliminary report to the Governor, the President of the Senate, and the Speaker of the House of Representatives by March 1, 2007, which identifies the supply and distribution of Florida-licensed dentists in Medicaid Services areas one and two of the Agency for Health Care Administration, indicates whether Florida-licensed dentists in such areas are retired or working full-time, and recommends strategies to improve a

1 broader distribution of dentists in these areas if a shortage
 2 or maldistribution is determined to exist. The division shall
 3 submit a final report to the presiding officer of each house
