10 (a) The department shall develop a Live the Dream license
11 plate as provided in this section. Live the Dream license plates
12 must bear the colors and design approved by the department. The
13 word "Florida" must appear at the top of the plate, and the
14 words "Live the Dream" must appear at the bottom of the plate.

15 (b) The proceeds of the annual use fee shall be
16 distributed to the Dream Foundation, Inc. The Dream Foundation,
17 Inc., shall retain the first \$60,000 in proceeds from the annual

18 use fees as reimbursement for administrative costs, startup
19 costs, and costs incurred in the approval process. Thereafter,
20 up to 25 percent shall be used for continuing promotion and
21 marketing of the license plate and concept. The remaining funds
22 shall be used in the following manner:

23 1. Twenty-five percent shall be distributed equally among
24 the 13 chapters of the Sickle Cell Disease Association of
25 Florida, Inc., the Sickle Cell Disease Association of
26 America--Volusia County Chapter, Inc., the Sickle Cell Disease
27 Association of America--Dade County Chapter, Inc., and the
28 Sickle Cell Disease Association of America--Northeast Florida
29 Chapter, Inc., ~~as grants~~ for programs that provide research,
30 care, and treatment for sickle cell disease.

31 2. Twenty-five percent shall be distributed to the Florida
32 chapter of the March of Dimes for programs and services that
33 improve the health of babies through the prevention of birth
34 defects and infant mortality.

35 3. Ten percent shall be distributed to the Florida
36 Association of Healthy Start Coalitions to decrease racial
37 disparity in infant mortality and to increase healthy birth
38 outcomes. Funding will be used by local Healthy Start Coalitions
39 to provide services and increase screening rates for high-risk
40 pregnant women, children under 4 years of age, and women of
41 childbearing age.

42 4. Ten percent shall be distributed to the Community
43 Partnership for Homeless, Inc., for programs that provide relief
44 from poverty, hunger, and homelessness.

45 5. Five percent of the proceeds shall be used by the
