10 (49) LIVE THE DREAM LICENSE PLATES.--

11 (a) The department shall develop a Live the Dream license
12 plate as provided in this section. Live the Dream license plates
13 must bear the colors and design approved by the department. The
14 word "Florida" must appear at the top of the plate, and the
15 words "Live the Dream" must appear at the bottom of the plate.

16 (b) The proceeds of the annual use fee shall be
17 distributed to the Dream Foundation, Inc. The Dream Foundation,

18 Inc., shall retain the first \$60,000 in proceeds from the annual
19 use fees as reimbursement for administrative costs, startup
20 costs, and costs incurred in the approval process. Thereafter,
21 up to 25 percent shall be used for continuing promotion and
22 marketing of the license plate and concept. The remaining funds
23 shall be used in the following manner:

24 1. Twenty-five percent shall be distributed equally among
25 all sickle cell associations registered in the State of Florida
26 ~~as grants~~ for programs that provide research, care, and
27 treatment for sickle cell disease.

28 2. Twenty-five percent shall be distributed to the Florida
29 chapter of the March of Dimes for programs and services that
30 improve the health of babies through the prevention of birth
31 defects and infant mortality.

32 3. Ten percent shall be distributed to the Florida
33 Association of Healthy Start Coalitions to decrease racial
34 disparity in infant mortality and to increase healthy birth
35 outcomes. Funding will be used by local Healthy Start Coalitions
36 to provide services and increase screening rates for high-risk
37 pregnant women, children under 4 years of age, and women of
38 childbearing age.

39 4. Ten percent shall be distributed to the Community
40 Partnership for Homeless, Inc., for programs that provide relief
41 from poverty, hunger, and homelessness.

42 5. Five percent of the proceeds shall be used by the
43 foundation for administrative costs directly associated with
44 operations as they relate to the management and distribution of
45 the proceeds.
