## I. Summary:

Chapter 985, F.S., addresses Florida's juvenile justice system. Some judges, prosecutors, defense attorneys, and agency personnel have indicated that the chapter's current organization is difficult to utilize in practice.

The bill reorganizes ch. 985, F.S., to provide a chronological presentation of the delinquency proceeding from the introduction of the child into the system to the case outcome. It divides the chapter into 13 parts. It also divides larger sections within the chapter into smaller parts that are given more meaningful section and subheading names to better describe and organize the chapter's contents.

The bill is designed to be strictly a technical rewrite of ch. 985, F.S., with no substantive changes to current law.

This bill substantially amends chapter 985 of the Florida Statutes.

## II. Present Situation:

Chapter 985, F.S., addresses Florida's juvenile justice system. Some judges, prosecutors, defense attorneys, and agency personnel have indicated that the chapter's current organization is difficult

to utilize in practice. For example, even though the chapter contains s. 985.201, F.S., entitled "Jurisdiction," wherein all matters related to juvenile jurisdiction presumably would be located, numerous other sections in the chapter also contain provisions relating to jurisdiction. *See e.g.* ss. 985.23, 985.231, 985.31, and 985.313, F.S.

To address this problem, in 2003, the Delinquency Subcommittee of the Steering Committee of Families and Children in the Court prepared a proposed reorganization of ch. 985, F.S. The subcommittee was comprised of representatives from the judiciary, the state attorney's office, the public defender's office, and the Department of Juvenile Justice. This bill is the result of the subcommittee's efforts.

#### III. Effect of Proposed Changes:

The bill is purely technical and is designed to make the juvenile delinquency statutes more "userfriendly" for all stakeholders: state attorneys, public defenders, children, parents, judges, employees of the Department of Juvenile Justice (DJJ), and private providers of delinquency services. "Whereas" clauses contained in the bill specify that the Legislature recognizes that ch. 985, F.S., has become disjointed and disorganized due to numerous amendments since its original enactment and that the Legislature intends for the bill, ". . . to strictly effect a technical reorganization of ch. 985, F.S., without any substantive change to its contents, for the purpose of simplifying the chapter's presentation and providing greater clarity for its users . . . ."

The bill reorganizes ch. 985, F.S., as follows:

**Chronological Presentation** -- Chapter 985, F.S., is reorganized to provide a chronological presentation of the delinquency proceeding from the introduction of the child into the system to the case outcome. It divides the chapter into the following 13 parts:

- 3. Custody and Intake; Intervention and Diversion
- 4. Examinations and Evaluations
- 5. Detention
- 6. Petition, Arraignment and Adjudication
- 7. Disposition; Post-Disposition

- 10. Transfer to Adult Court
- 11. Department of Juvenile Justice
- 12. Miscellaneous Offenses
- 13. Interstate Compact on Juveniles

Representatives from the Office of the State Court Administrator have indicated that such costs can be absorbed by existing resources.
