- (3) For filing an original application for registration as a foreign limited partnership, \$965.
 - (4) For filing certificate of conversion, \$52.50.
- 8 (5) For filing certificate of merger, \$52.50 for each party thereto.
- 10 (6) For filing a reinstatement, \$500 for each calendar 11 year or part thereof the limited partnership was 12 administratively dissolved or foreign limited partnership was 13 revoked in the records of the Department of State.
 - (7) For filing an annual report, \$411.25.
 - (8) For filing a certificate:
 - (a) Designating a registered agent, \$35;
