The notice of intent to approve 9 10 and the notice of intent to disapprove constitute agency 11 action for purposes of the Administrative Procedure Act. Requests for supporting information, requests for mathematical 12 13 or mechanical corrections, or notification to the insurer by the office of its preliminary findings shall not toll the 14 15 90-day period during any such proceedings and subsequent judicial review. The rate shall be deemed approved if the 16 office does not issue a notice of intent to approve or a 17 notice of intent to disapprove within 90 days after receipt of 18 19 the filing. 20 2. If the filing is not made in accordance with the provisions of subparagraph 1., such filing shall be made as 21 22 soon as practicable, but no later than 30 days after the 23 effective date, and shall be considered a "use and file" 2.4 filing.
