In the case of assault, from a misdemeanor of the 1 (a) 2 second degree to a misdemeanor of the first degree. 3 (b) In the case of battery, from a misdemeanor of the 4 first degree to a felony of the third degree. 5 (c) In the case of aggravated assault, from a felony 6 of the third degree to a felony of the second degree. 7 Notwithstanding any other provision of law, any person convicted of aggravated assault upon a law enforcement officer 8 shall be sentenced to a minimum term of imprisonment of 3 9 10 years. 11 (d) In the case of aggravated battery, from a felony 12 of the second degree to a felony of the first degree. 13 Notwithstanding any other provision of law, any person convicted of aggravated battery of a law enforcement officer 14 shall be sentenced to a minimum term of imprisonment of 5 15 16 years. 17 Section 2.
