(1) Effective May 21, 2006, through June 11 12 1, 2006, and May 20, 2007, through May 31, 2007, no tax levied 13 under the provisions of chapter 212, Florida Statutes, shall be collected on the sale of: 14 (a) Any portable self-powered light source selling for 15 16 \$20 or less. 17 (b) Any portable self-powered radio, two-way radio, or 18 weatherband radio selling for \$50 or less. (c) Any tarpaulin or other flexible waterproof 19 sheeting selling for \$50 or less. 20 21 (d) Any ground anchor system or tie-down kit selling 22 for \$50 or less. 23 (e) Any gas or diesel fuel tank selling for \$25 or 2.4 less. (f) Any package of AAA-cell, AA-cell, C-cell, D-cell, 25 26 6-volt, or 9-volt batteries, excluding automobile and boat <u>batteries, selling for \$30 or less.</u> 27 2.8 (q) Any cell phone battery selling for \$60 or less and any cell phone charger selling for \$40 or less. 29 30 (h) Any nonelectric food storage cooler selling for 31 <u>\$30 or less.</u>

Section 2. The sum of \$221,400 is appropriated from 8 9 the General Revenue Fund to the Department of Revenue for 10 purposes of administering section 1. Section 3.
