Section 787.06, Florida Statutes, is 21 22 amended to read: 23 787.06 Human trafficking.--24 (1)(a) The Legislature finds that human trafficking is a form of modern-day slavery. Victims of human trafficking are 25 young children, teenagers, and adults. Thousands of victims 26 are trafficked annually across international borders 2.7 28 worldwide. Many of these victims are trafficked into this 29 state. The Legislature finds that victims of human trafficking are subjected to force, fraud, or coercion for the purpose of 30

sexual exploitation or forced labor.

(b) The Legislature finds that while many victims of 2 human trafficking are forced to work in prostitution or the sexual entertainment industry, trafficking also occurs in 3 forms of labor exploitation, such as domestic servitude, 4 restaurant work, janitorial work, sweatshop factory work, and 5 migrant agricultural work. 6 7 (c) The Legislature finds that traffickers use various 8 techniques to instill fear in victims and to keep them 9 enslaved. Some traffickers keep their victims under lock and key. However, the most frequently used practices are less 10 obvious techniques that include isolating victims from the 11 public and family members; confiscating passports, visas, or 12 13 other identification documents; using or threatening to use 14 violence toward victims or their families; telling victims that they will be imprisoned or deported for immigration 15 violations if they contact authorities; and controlling the 16 victims' funds by holding the money ostensibly for 17 18 safekeeping. 19 (d) It is the intent of the Legislature that the perpetrators of human trafficking be penalized for their 20 illegal conduct and that the victims of trafficking be 2.1 22 protected and assisted by this state and its agencies.
