1 other supportive services which may be specified by rule. The
2 purpose of such services is to enable residents to age in
3 place in a residential environment despite mental or physical
4 limitations that might otherwise disqualify them from
5 residency in a facility licensed under this part.

6 (13) "Guardian" means a person to whom the law has
7 entrusted the custody and control of the person or property,
8 or both, of a person who has been legally adjudged
9 incapacitated.

10 (14) "Limited nursing services" means acts that may be
11 performed pursuant to part I of chapter 464 by persons
12 licensed thereunder while carrying out their professional
13 duties but limited to those acts which the department
14 specifies by rule. Acts which may be specified by rule as
15 allowable limited nursing services shall be for persons who
16 meet the admission criteria established by the department for
17 assisted living facilities and shall not be complex enough to
18 require 24-hour nursing supervision and may include such
19 services as the application and care of routine dressings, and
20 care of casts, braces, and splints.

21 (15) "Managed risk" means the process by which the
22 facility staff discuss the service plan and the needs of the

3 (21) "Resident's representative or designee" means a
4 person other than the owner, or an agent or employee of the
5 facility, designated in writing by the resident, if legally
6 competent, to receive notice of changes in the contract
7 executed pursuant to s. 429.24 ~~s. 400.424~~; to receive notice
8 of and to participate in meetings between the resident and the
9 facility owner, administrator, or staff concerning the rights
10 of the resident; to assist the resident in contacting the
11 ombudsman council if the resident has a complaint against the
12 facility; or to bring legal action on behalf of the resident
13 pursuant to s. 429.29 ~~s. 400.429~~.

14 (22) "Service plan" means a written plan, developed
15 and agreed upon by the resident and, if applicable, the
16 resident's representative or designee or the resident's
17 surrogate, guardian, or attorney in fact, if any, and the
18 administrator or designee representing the facility, which
19 addresses the unique physical and psychosocial needs,
20 abilities, and personal preferences of each resident receiving
21 extended congregate care services. The plan shall include a
22 brief written description, in easily understood language, of
23 what services shall be provided, who shall provide the
24 services, when the services shall be rendered, and the
25 purposes and benefits of the services.

26 (23) "Shared responsibility" means exploring the
27 options available to a resident within a facility and the
28 risks involved with each option when making decisions
29 pertaining to the resident's abilities, preferences, and

22 meals, and personal services must own or rent the home and

26 wherein care is provided exclusively to three or fewer

12 to persons who otherwise would be disqualified from continued
13 residence in a facility licensed under this part.

14 1. In order for extended congregate care services to
15 be provided in a facility licensed under this part, the agency
16 must first determine that all requirements established in law

18 facility's license, that such services may be provided and
19 whether the designation applies to all or part of a facility.

23 designee, representing the agency shall visit such facilities
24 at least quarterly to monitor residents who are receiving
25 extended congregate care services and to determine if the

14 qualified person as a receiver, except it may not appoint any
15 owner or affiliate of the facility which is in receivership.
16 The receiver may be selected from a list of persons qualified
17 to act as receivers developed by the agency and presented to
18 the court with each petition for receivership. Under no
19 circumstances may the agency or designated agency employee be
20 appointed as a receiver for more than 60 days; however, the
21 receiver may petition the court, one time only, for a 30-day
22 extension. The court shall grant the extension upon a showing
23 of good cause.

24 (3) The receiver must make provisions for the
25 continued health, safety, and welfare of all residents of the
26 facility and:

27 (a) Shall exercise those powers and perform those
28 duties set out by the court.

29 (b) Shall operate the facility in such a manner as to
30 assure safety and adequate health care for the residents.

1 (c) Shall take such action as is reasonably necessary
2 to protect or conserve the assets or property of the facility
3 for which the receiver is appointed, or the proceeds from any

3 | (h) Shall have full power to direct and manage and to

10 | (i) Shall be entitled to and take possession of all
11 | property or assets of residents which are in the possession of

13 | property, assets, and records of residents of which the
14 | receiver takes possession and shall provide for the prompt

16 | placement of any transferred resident. An inventory list

18 | at the time the receiver takes possession of the facility.

7 entered into by the owner of the facility if the rent, price,
8 or rate of interest required to be paid under the agreement

13 conditions. Any relief in this form provided by the court
14 shall be limited to the life of the receivership, unless

16 (b) If the receiver is in possession of real estate or
17 goods subject to a lease, mortgage, or security interest which
18 the receiver has obtained a court order to avoid under
19 paragraph (a), and if the real estate or goods are necessary
20 for the continued operation of the facility under this
21 section, the receiver may apply to the court to set a
22 reasonable rental, price, or rate of interest to be paid by
23 the receiver during the duration of the receivership. The
24 court shall hold a hearing on the application within 15 days.
25 The receiver shall send notice of the application to any known
26 persons who own the property involved at least 10 days prior
27 to the hearing. Payment by the receiver of the amount
28 determined by the court to be reasonable is a defense to any
29 action against the receiver for payment or for possession of
30 the goods or real estate subject to the lease, security
31 interest, or mortgage involved by any person who received such

1 notice, but the payment does not relieve the owner of the
2 facility of any liability for the difference between the
3 amount paid by the receiver and the amount due under the

5 (6) The court shall set the compensation of the
6 receiver, which will be considered a necessary expense of a

8 (7) A receiver may be held liable in a personal
9 capacity only for the receiver's own gross negligence,

11 (8) The court may require a receiver to post a bond.

12 (9) The court may direct the agency to allocate funds
13 from the Health Care Trust Fund to the receiver, subject to
14 the provisions of s. 429.18(1) ~~s. 400.418(1)~~.

15 (10) The court may terminate a receivership when:

16 (a) The court determines that the receivership is no
17 longer necessary because the conditions which gave rise to the
18 receivership no longer exist or the agency grants the facility
19 a new license; or

20 (b) All of the residents in the facility have been
21 transferred or discharged.

22 (11) Within 30 days after termination, the receiver
23 shall give the court a complete accounting of all property of
24 which the receiver has taken possession, of all funds
25 collected, and of the expenses of the receivership.

26 (12) Nothing in this section shall be deemed to
27 relieve any owner, administrator, or employee of a facility
28 placed in receivership of any civil or criminal liability
29 incurred, or any duty imposed by law, by reason of acts or
30 omissions of the owner, administrator, or employee prior to
31 the appointment of a receiver; nor shall anything contained in

1 | this section be construed to suspend during the receivership

1 | team designated by the agency shall then determine whether the
2 | resident is appropriately residing in the facility. The
3 | medical review team shall base its decision on a comprehensive
4 | review of the resident's physical and functional status,
5 | including the resident's preferences, and not on an isolated
6 | health-related problem. In the case of a mental health
7 | resident, if the resident appears to have needs in addition to
8 | those identified in the community living support plan, the
9 | agency may require an evaluation by a mental health
10 | professional, as determined by the Department of Children and
11 | Family Services. A facility may not be required to retain a
12 | resident who requires more services or care than the facility
13 | is able to provide in accordance with its policies and
14 | criteria for admission and continued residency. Members of the
15 | medical review team making the final determination may not
16 | include the agency personnel who initially questioned the
17 | appropriateness of a resident's placement. Such determination
18 | is final and binding upon the facility and the resident. Any
19 | resident who is determined by the medical review team to be
20 | inappropriately residing in a facility shall be given 30 days'
21 | written notice to relocate by the owner or administrator,
22 | unless the resident's continued residence in the facility
23 | presents an imminent danger to the health, safety, or welfare
24 | of the resident or a substantial probability exists that death
25 | or serious physical harm would result to the resident if
26 | allowed to remain in the facility.

27 | (10) A terminally ill resident who no longer meets the
28 | criteria for continued residency may remain in the facility if
29 | the arrangement is mutually agreeable to the resident and the
30 | facility; additional care is rendered through a licensed

3 (11) Facilities licensed to provide extended
4 congregate care services shall promote aging in place by

9 care and services required; and documentation that a written
10 service plan consistent with facility policy has been

22 (1)(a) A resident shall be given the option of using
23 his or her own belongings, as space permits; choosing his or
24 her roommate; and, whenever possible, unless the resident is

27 (b) The admission of a resident to a facility and his
28 or her presence therein shall not confer on the facility or
29 its owner, administrator, employees, or representatives any

13 (7) In the event of the death of a resident, a

17 and, if not, to the resident's spouse or adult next of kin
18 named in a beneficiary designation form provided by the
19 facility to the resident. If the resident has no spouse or

15 (a) Live in a safe and decent living environment, free

12 (g) Share a room with his or her spouse if both are

14 (h) Reasonable opportunity for regular exercise
15 several times a week and to be outdoors at regular and
16 frequent intervals except when prevented by inclement weather.

17 (i) Exercise civil and religious liberties, including
18 the right to independent personal decisions. No religious
19 beliefs or practices, nor any attendance at religious
20 services, shall be imposed upon any resident.

21 (j) Access to adequate and appropriate health care
22 consistent with established and recognized standards within

24 (k) At least 45 days' notice of relocation or
25 termination of residency from the facility unless, for medical
26 reasons, the resident is certified by a physician to require
27 an emergency relocation to a facility providing a more skilled
28 level of care or the resident engages in a pattern of conduct
29 that is harmful or offensive to other residents. In the case
30 of a resident who has been adjudicated mentally incapacitated,

6 (1) Present grievances and recommend changes in

10 reprisal. Each facility shall establish a grievance procedure

12 right includes access to ombudsman volunteers and advocates

11 (8) Each request for and notice concerning informal

29 the issues of liability and damages in accordance with the

23 The beginning date from which the deadline for the automatic

30 j. It is recognized that the installation of an

12 (g) The enforcement of the resident bill of rights
13 specified in s. 429.28 ~~s. 400.428~~.

14 (h) The care and maintenance of residents, which must
15 include, but is not limited to:

- 16 1. The supervision of residents;
- 17 2. The provision of personal services;
- 18 3. The provision of, or arrangement for, social and
19 leisure activities;
- 20 4. The arrangement for appointments and transportation
21 to appropriate medical, dental, nursing, or mental health
22 services, as needed by residents;
- 23 5. The management of medication;
- 24 6. The nutritional needs of residents;
- 25 7. Resident records; and
- 26 8. Internal risk management and quality assurance.

27 (i) Facilities holding a limited nursing, extended
28 congregate care, or limited mental health license.

29 (j) The establishment of specific criteria to define
30 appropriateness of resident admission and continued residency
31

1 in a facility holding a standard, limited nursing, extended
2 congregate care, and limited mental health license.

3 (k) The use of physical or chemical restraints. The
4 use of physical restraints is limited to half-bed rails as
5 prescribed and documented by the resident's physician with the
6 consent of the resident or, if applicable, the resident's
7 representative or designee or the resident's surrogate,
8 guardian, or attorney in fact. The use of chemical restraints
9 is limited to prescribed dosages of medications authorized by
10 the resident's physician and must be consistent with the
11 resident's diagnosis. Residents who are receiving medications
12 that can serve as chemical restraints must be evaluated by
13 their physician at least annually to assess:

14 1. The continued need for the medication.

15 2. The level of the medication in the resident's

17 3. The need for adjustments in the prescription.

18 (1) The establishment of specific policies and
19 procedures on resident elopement. Facilities shall conduct a
20 minimum of two resident elopement drills each year. All
21 administrators and direct care staff shall participate in the
22 drills. Facilities shall document the drills.

23 (2) In adopting any rules pursuant to this part, the
24 department, in conjunction with the agency, shall make
25 distinct standards for facilities based upon facility size;
26 the types of care provided; the physical and mental
27 capabilities and needs of residents; the type, frequency, and
28 amount of services and care offered; and the staffing
29 characteristics of the facility. Rules developed pursuant to
30 this section shall not restrict the use of shared staffing and
31 shared programming in facilities that are part of retirement

1 communities that provide multiple levels of care and otherwise
