30-477B-06 1 Senate Memorial 2 A memorial to the Florida delegation to the United States House of Representatives, urging 3 unified resistance to proposals for the 4 5 revision of measures protecting the coastline б of Florida against oil and gas drilling. 7 8 WHEREAS, Florida's Congressional Delegation has long 9 stood united against proposals for oil and gas drilling off 10 the state's coasts, and WHEREAS, across party lines, Florida's Congressional 11 12 representatives have long recognized that protection of 13 Florida's fragile coastal ecology is vital to the state's economy as well as its ecology, and have understood that, in 14 Florida, the economy and the ecology are indeed inseparable, 15 16 and 17 WHEREAS, temporary energy shortages in the wake of Hurricanes Katrina and Rita have encouraged oil- and 18 gas-drilling interests to attempt to break down defenses that 19 have thus far protected Florida's coastal resources from many 20 21 of the pollution and contamination risks of our time, and 22 WHEREAS, the United States Department of the Interior 23 has estimated that hydrocarbon reserves off western Florida and the Panhandle would meet only about 200 days of the 2.4 nation's gasoline and heating oil needs projected for this 25 winter, and 26 27 WHEREAS, in practical terms, these reserves would not 2.8 become available for at least 2 years, and a possible maximum of 10 years, after drilling begins, and thus do not constitute 29 a solution to the immediate shortfall or a justification for 30 31
