Appropriations (Dockery) recommended the following amendment:

Senate Amendment (with title amendment)

On page 2, between lines 3 and 4,

insert:

Section 2. Subsection (4) of section 320.08068,
Florida Statutes, is amended to read:

320.08068 Motorcycle specialty license plates.--

(4) A license plate annual use fee of \$15 shall be
collected for each motorcycle specialty license plate. Annual
use fees shall be distributed to The Able Trust as custodial
agent. The Able Trust may retain a maximum of 10 percent of
the proceeds from the sale of the license plate for
administrative costs. The Able Trust shall distribute the
remaining funds as follows:

(a) Twenty-five percent to the Brain and Spinal Cord
Injury Program Trust Fund.

(b) Twelve and one-half ~~Twenty-five~~ percent to Prevent
Blindness Florida.
