Section 406.135, Florida Statutes, is 14 amended to read: 15 406.135 Autopsies; confidentiality of photographs and 16 17 video and audio recordings; exemption. --(1) A photograph or video or audio recording of an 18 autopsy in the custody of a medical examiner is confidential 19 and exempt from the requirements of s. 119.07(1) and s. 24(a), 20 21 Art. I of the State Constitution, except that a surviving 22 spouse may view and copy a photograph or video or listen to or 23 copy an audio recording of the deceased spouse's autopsy. If there is no surviving spouse, then the surviving parents shall 2.4 have access to such records. If there is no surviving spouse 25 or parent, then an adult child shall have access to such 26 27 records. However, the deceased's surviving relative, with whom 2.8 authority rests to obtain such records, may designate in 29 writing an agent to obtain such records. A local governmental entity, or a state or federal agency, in furtherance of its 30 official duties, pursuant to a written request, may view or

copy a photograph or video or may listen to or copy an audio recording of an autopsy, and unless otherwise required in the performance of their duties, the identity of the deceased shall remain confidential and exempt. The custodian of the record, or his or her designee, may not permit any other person, except an agent designated in writing by the deceased's surviving relative with whom authority rests to obtain such records, to view or copy such photograph or video recording or listen to or copy an audio recording without a court order. For the purposes of this section, the term "medical examiner" means any district medical examiner, associate medical examiner, or substitute medical examiner acting pursuant to this chapter, as well as any employee, deputy, or agent of a medical examiner or any other person who may obtain possession of a photograph or audio or video recording of an autopsy in the course of assisting a medical examiner in the performance of his or her official duties. (2)(a) The court, upon a showing of good cause, may issue an order authorizing any person to view or copy a photograph or video recording of an autopsy or to listen to or copy an audio recording of an autopsy and may prescribe any restrictions or stipulations that the court deems appropriate. In determining good cause, the court shall consider whether such disclosure is necessary for the public evaluation of

an autopsy must be under the direct supervision of the custodian of the record or his or her designee.

- (b) A surviving spouse shall be given reasonable notice of a petition filed with the court to view or copy a photograph or video recording of an autopsy or a petition to listen to or copy an audio recording, a copy of such petition, and reasonable notice of the opportunity to be present and heard at any hearing on the matter. If there is no surviving spouse, then such notice must be given to the deceased's parents, and if the deceased has no living parent, then to the adult children of the deceased.
- (3)(a) Any custodian of a photograph or video or audio recording of an autopsy who willfully and knowingly violates this section commits a felony of the third degree, punishable as provided in s. 775.082, s. 775.083, or s. 775.084.
- (b) Any person who willfully and knowingly violates a court order issued pursuant to this section commits a felony of the third degree, punishable as provided in s. 775.082, s. 775.083, or s. 775.084.
- (c) A criminal or administrative proceeding is exempt from this section, but unless otherwise exempted, is subject to all other provisions of chapter 119, provided however that this section does not prohibit a court in a criminal or administrative proceeding upon good cause shown from restricting or otherwise controlling the disclosure of an autopsy, crime scene, or similar photograph or video or audio recordings in the manner prescribed herein.
- (4) This exemption shall be given retroactive application.
- 30 (5) The exemption in this section is subject to the
 31 Open Government Sunset Review Act of 1995 in accordance with
