Paragraph (c) of subsection (3) of section 18 316.066, Florida Statutes, is amended to read: 316.066 Written reports of crashes.--19 (3) 20 21 (c) Crash reports required by this section which 22 reveal the identity, home or employment telephone number or 23 home or employment address of, or other personal information concerning the parties involved in the crash and which are 2.4 received or prepared by any agency that regularly receives or 25 prepares information from or concerning the parties to motor 26 27 vehicle crashes are confidential and exempt from s. 119.07(1) 28 and s. 24(a), Art. I of the State Constitution for a period of 29 60 days after the date the report is filed. However, such reports may be made immediately available to the parties 30 involved in the crash, their legal representatives, their

licensed insurance agents, their insurers or insurers to which 2 they have applied for coverage, persons under contract with such insurers to provide claims or underwriting information, 3 prosecutorial authorities, victim services programs, radio and 4 television stations licensed by the Federal Communications 5 6 Commission, newspapers qualified to publish legal notices 7 under ss. 50.011 and 50.031, and free newspapers of general 8 circulation, published once a week or more often, available 9 and of interest to the public generally for the dissemination of news. For the purposes of this section, the following 10 products or publications are not newspapers as referred to in 11 12 this section: those intended primarily for members of a 13 particular profession or occupational group; those with the primary purpose of distributing advertising; and those with 14 the primary purpose of publishing names and other personal 15 identifying information concerning parties to motor vehicle 16 17 crashes. Any local, state, or federal agency, victim services 18 program, agent, or employee that is authorized to have access to such reports by any provision of law shall be granted such 19 access in the furtherance of the agency's statutory duties 20 21 notwithstanding the provisions of this paragraph. Any local, 22 state, or federal agency, agent, or employee receiving such 23 crash reports shall maintain the confidential and exempt status of those reports and shall not disclose such crash 2.4 25 reports to any person or entity. As a condition precedent to 26 accessing a crash report within 60 days after the date the 27 report is filed, a person must present a valid driver's 2.8 license or other photographic identification, proof of status, 29 or identification that demonstrates his or her qualifications to access that information, and file a written sworn statement 30 with the state or local agency in possession of the

information stating that information from a crash report made 2 confidential by this section will not be used for any commercial solicitation of accident victims, or knowingly 3 4 disclosed to any third party for the purpose of such solicitation, during the period of time that the information 5 remains confidential. In lieu of requiring the written sworn statement, an agency may provide crash reports by electronic 8 means to third-party vendors under contract with one or more insurers, but only when such contract states that information 9 from a crash report made confidential by this section will not 10 be used for any commercial solicitation of accident victims by 11 12 the vendors, or knowingly disclosed by the vendors to any 13 third party for the purpose of such solicitation, during the period of time that the information remains confidential, and 14 only when a copy of such contract is furnished to the agency 15 as proof of the vendor's claimed status. This subsection does 16 not prevent the dissemination or publication of news to the general public by any legitimate media entitled to access 18 confidential information pursuant to this section. A law 19 enforcement officer as defined in s. 943.10(1) may enforce 20 21 this subsection. This exemption is subject to the Open 22 Government Sunset Review Act of 1995 in accordance with s. 23 119.15, and shall stand repealed on October 2, 2006, unless 2.4 reviewed and saved from repeal through reenactment by the 2.5 Legislature.
