36 641.51(4). Should the office determine that the fiscal
37 intermediary services organization does not meet the
38 requirements of this section, the registration shall be denied.
39 In the event that the registrant fails to maintain compliance
40 with the provisions of this section, the office may revoke or
41 suspend the registration. In lieu of revocation or suspension of
42 the registration, the office may levy an administrative penalty
43 in accordance with s. 641.25.
