2 An act relating to building designations; designating the
3 new alumni center at Florida Atlantic University as the
4 Marleen and Harold Forkas Alumni Center; designating the
5 Florida Agricultural and Mechanical University-Florida
6 State University College of Engineering Building as the
7 Herbert F. Morgan Building; designating the art museum at
8 the University Park Campus of Florida International
9 University as the Patricia and Phillip Frost Art Museum;
10 designating the dining room in the Hungry Ram Restaurant
11 as the Barbara Finlayson Dining Room; designating the
12 Florida State Hospital Administration Building as the
13 William DeWitt Rogers Administration Building; directing
14 the erection of suitable markers; providing an effective
15 date.

17 Be It Enacted by the Legislature of the State of Florida:

19 Section 1. Marleen and Harold Forkas Alumni Center
20 designated; Florida Atlantic University to erect suitable
21 markers.--

22 (1) The new alumni center at Florida Atlantic University
23 is designated as the "Marleen and Harold Forkas Alumni Center."

24 (2) Florida Atlantic University is directed to erect
25 suitable markers designating the Marleen and Harold Forkas
26 Alumni Center as described in subsection (1).

27 Section 2. Herbert F. Morgan Building designated; Florida
 28 Agricultural and Mechanical University and Florida State
 29 University to erect suitable markers.--

30 (1) The Florida Agricultural and Mechanical University-
 31 Florida State University College of Engineering Building in
 32 Tallahassee is designated as the "Herbert F. Morgan Building."

33 (2) Florida Agricultural and Mechanical University and
 34 Florida State University are directed to erect suitable markers
 35 designating the Herbert F. Morgan Building as described in
 36 subsection (1).

37 Section 3. Patricia and Phillip Frost Art Museum
 38 designated; Florida International University to erect suitable
 39 markers.--

40 (1) The art museum on the campus of Florida International
 41 University, University Park Campus in Miami, is designated as
 42 the "Patricia and Phillip Frost Art Museum."

43 (2) The Florida International University is directed to
 44 erect suitable markers designating the Patricia and Phillip
 45 Frost Art Museum as described in subsection (1).

46 Section 4. Barbara Finlayson Dining Room designated;
 47 District School Board of Alachua County to erect suitable
 48 markers.--

49 (1) The dining room in the Hungry Ram Restaurant in the
 50 Gainesville Eastside High School Commercial Foods Program in the
 51 City of Gainesville is designated as the "Barbara Finlayson
 52 Dining Room."

53 (2) The District School Board of Alachua County is
54 directed to erect suitable markers designating the Barbara
55 Finlayson Dining Room as described in subsection (1).

56 Section 5. William DeWitt Rogers Administration Building
57 designated; Department of Management Services to erect suitable
58 markers.--

59 (1) The Florida State Hospital Administration Building at
60 100 West Main Street in the City of Chattahoochee is designated
61 as the "William DeWitt Rogers Administration Building."

62 (2) The Department of Management Services is directed to
63 erect suitable markers designating the William DeWitt Rogers
64 Administration Building as described in subsection (1).

65 Section 6. This act shall take effect upon becoming a law.
