Except as 25 stated herein and as provided by section s. 287.055, Florida 26 27 Statutes, as amended, no contract shall be let by the board for the construction or maintenance of any improvements authorized 28 29 under chapter 98-524, Laws of Florida, as amended this act, nor shall any goods, supplies, or materials be purchased when the 30 amount thereof to be paid by the district shall exceed the 31 threshold amount provided in section 287.017(1), Florida 32 Statutes, as amended, for CATEGORY TWO \$10,000, unless notice of 33 bids shall be advertised once a week for 2 consecutive weeks in 34 35 a newspaper in general circulation in Broward County, and in 36 each case the bid of the lowest responsible bidder shall be 37 accepted, unless all bids are rejected because the bids are too 38 high. The board may require the bidders to furnish bond with responsible surety to be approved by the board.
