SUMMARY ANALYSIS

This bill revises the residence requirements for governing board members of the Southwest Florida Water Management District. It sets the number of board members from Hillsborough or Pinellas counties to two each by deleting language that gives Hillsborough or Pinellas an additional "at large" member designation.

The bill increases, from 1 to 2, the number of board members that reside in Polk County.

The bill also revises the qualifications for the "at large" seats on the board to provide for: one 'at large" member to be from Levy, Marion, Citrus, Sumter, Hernando, and Lake Counties; one 'at large" member to be from Hardee, DeSoto, and Highlands Counties; and one "at large" member to be from Sarasota and Charlotte Counties.

I. SUBSTANTIVE ANALYSIS

Section 1. Amends subsection (e) of subsection (2) of section 373.073, F.S.;

- Deleting the requirement that one member shall reside in Hillsborough and Pinellas County. These two counties would still each have two members.
- Increasing the number of board members from Polk County from 1 to 2.
- Clarifying that of the 3 at large board members, appointed from the following counties; Levy, Marion, Citrus, Sumter, Hernando Lake, Sarasota, Hardee, DeSoto, Charlotte, or Highlands, no county may have more than one representative.

Section 2. This bill shall take effect upon becoming a law.
