SUMMARY ANALYSIS

HB 107 designates the Florida Orchestra, located in the Tampa Bay area, as the official state orchestra. Current law provides 34 state designations (i.e., beverage, shell, stone, animal, butterfly, etc.); however, Florida does not have a state designated orchestra.

This bill takes effect upon becoming law.

This bill does not appear to have a fiscal impact on state or local governments.

FULL ANALYSIS

I. SUBSTANTIVE ANALYSIS

A. HOUSE PRINCIPLES ANALYSIS:

This bill does not appear to implicate any of the House Principles.

B. EFFECT OF PROPOSED CHANGES:

Current Situation

Chapter 15, F.S., designates official state emblems. It contains 34 state designations, included in those designations are an official state opera program and the official state band¹. Chapter 15 does not contain a designation for an official state orchestra.

The Florida Orchestra was founded in 1968 as the Florida Gulf Coast Symphony; a combination of the Tampa Philharmonic and the St. Petersburg Symphony. The Florida Orchestra is in its 40th season of performances, and employs a full orchestra of over 80 professional musicians. Based in the Tampa Bay area, the Florida Orchestra participates in the community through education and outreach programs, many of which are integrated into public school district curricula. The orchestra offers over 130 performances a year. Fifty of these performances are free and are held throughout the season reaching 40,000 students, including large percentages of minority and low-income children.

The American Symphony Orchestra League includes 31 Florida orchestras as its members.² The American Symphony Orchestra League has established tiers to categorize Orchestras by budget size and characteristics.³ The tiers serve as a means of grouping similar orchestras and encourage the sharing of ideas on the many similar issues they face, they do not seek to define the quality of the orchestra. The Florida Orchestra is considered a Tier 2 Orchestra, with an operating budget of \$10.8 million. According to the American Symphony Orchestra League, this is the largest operating budget of any Florida orchestra, although The Jacksonville Symphony, The Naples Philharmonic and The New World Symphony fall within the same tier grouping established. The Florida Orchestra also employs over 80 full time musicians, the largest number of any orchestra in Florida.

Proposed Changes

The bill designates the Florida Orchestra as the official state orchestra.
