8 Be It Enacted by the Legislature of the State of Florida:

10 Section 1. Subsection (1) of section 6 of chapter 2003-
11 368, Laws of Florida, is amended to read:

12 Section 6. Governing Body.

13 (1) The governing body of the Authority shall consist of
14 five permanent members and one or more interlocal members, as
15 may be appointed, acting as the Board of Supervisors, each of
16 whom shall serve a term of 3 years commencing on October 1,
17 provided the procedure for appointment of members of the Board
18 of Supervisors and their initial terms of office shall be as
19 follows:

20 (a) Board Supervisor No. 1 and Board Supervisor No. 2
21 shall serve for initial terms of approximately 2 years, ending
22 on September 30, 2005. Board Supervisor No. 1 shall be appointed
23 by the Osceola County Board of County Commissioners. Board
24 Supervisor No. 2 shall be appointed by the City Commission of
25 the City of Kissimmee.

26 (b) Board Supervisor No. 3 and Board Supervisor No. 4
27 shall serve initial terms of approximately 3 years, ending on
28 September 30, 2006. Board Supervisor No. 3 shall be appointed by

29 | the Osceola Board of County Commissioners. Board Supervisor No.
30 | 4 shall be appointed by the City Commission of the City of
31 | Kissimmee.

32 | (c) Board Supervisor No. 5 shall serve an initial term of
33 | approximately 4 years, ending September 30, 2007. Board
34 | Supervisor No. 5 shall be collectively appointed by joint
35 | resolution of the Osceola County Board of County Commissioners
36 | and the City Commission of the City of Kissimmee and shall serve
37 | as the Chairperson of the Board of Supervisors.

38 | (d) By resolution, one additional Board Supervisor may be
39 | appointed by each additional general-purpose local government
40 | that has adopted a resolution authorizing the Authority to
41 | provide services and facilities within a service area within its
42 | boundaries and that has entered into an interlocal agreement
43 | with the Authority authorizing the Authority to provide its
44 | potable or nonpotable water or wastewater management or delivery
45 | services or programs to retail customers within such service
46 | area, provided such interlocal agreement expressly provides for
47 | the appointment of such interlocal member of the Board of
48 | Supervisors. Such appointment shall be effective only for so
49 | long as the interlocal agreement is effective. Any interlocal
50 | member appointed to the Board of Supervisors shall serve an
51 | initial term of not more than 3 years, ending on September 30 of
52 | the final year of the term.

53 | Section 2. This act shall take effect upon becoming a law.
