FULL ANALYSIS

I. SUBSTANTIVE ANALYSIS

A. HOUSE PRINCIPLES ANALYSIS:

Provide Limited Government – This bill may reduce the size of government by abolishing the Upper Florida Keys Hospital District.

B. EFFECT OF PROPOSED CHANGES:

Current Situation

The Upper Florida Keys Hospital District is an independent special district created by special act in 1969.¹ The District has the authority to assess ad valorem taxes.² However, the District has not collected revenue or performed any public function for more than 18 years. On October 19, 2005, the County Commissioners of Monroe County passed resolution 381-2005 desiring that, pursuant to s. 189.4042, F.S., the District be dissolved, and stating that Monroe County supports legislation which would dissolve the District.

Dissolution Procedures for Independent Special Districts

Section 189.4042, F.S., provides that "for any independent district that has ad valorem taxation powers, the same procedure required to grant such independent district ad valorem taxation powers shall also be required to dissolve or merge the district." Therefore, the procedure in this case is for the Legislature to pass a special act repealing the creation of the District.

Effect of Proposed Changes

The bill repeals the special act that created the District.
