415 (f) The booking photograph taken when the offender was  
416 arrested.

417 (2) The information required in subsection (1) shall be  
418 provided to the Department of Law Enforcement electronically by  
419 the clerk of the court for the county in which the sentence is  
420 imposed within 10 days after the date the offender is sentenced.

421 (3) The Department of Law Enforcement must place the  
422 information on the website within 5 business days after the date  
423 it receives the information. The information shall remain on the  
424 website for 5 years after the date of posting.

425 (4) The department shall not allow the public to access  
426 information in the database that is confidential and exempt from  
427 public disclosure under s. 119.07(1) and s. 24(a), Art. I of the
