2 An act relating to a public records and public meetings 3 exemption; creating s. 1004.433, F.S.; providing an exemption from public records requirements for records and 4 information in the possession of Boca Raton Community 5 Hospital, Inc., or a subsidiary thereof, in its capacity 6 7 as lessee of land from Florida Atlantic University 8 pursuant to an agreement for the implementation of a land 9 lease for the development and operation of a communityuniversity affiliated teaching hospital which will serve 10 as the primary teaching hospital for the regional campus 11 of the University of Miami Miller School of Medicine at 12 Florida Atlantic University; providing an exception to the 13 exemption; providing an exemption from public meetings 14 requirements for meetings or portions of meetings of the 15 16 board of directors of Boca Raton Community hospital, or a subsidiary thereof, in its capacity as lessee; providing 17 an exception to the exemption; providing an exemption from 18 19 public records requirements for any records generated during those meetings or portions of meetings of the board 20 of directors of Boca Raton Community Hospital, or a 21 subsidiary thereof, which are closed to the public under 22 the act; providing for review and repeal; providing a 23 24 statement of public necessity; providing an effective 25 date. 26

Section 1004.433, Florida Statutes, is created 30 to read: 1004.433 Florida Atlantic University & Boca Raton 31 Community Hospital, Inc., Community-University Affiliated 32 Teaching Hospital; public records exemption; public meetings 33 exemption. --34 35 (1) For purposes of this section, "lessee" means the Boca Raton Community Hospital, Inc., pursuant to the agreement signed 36 37 June 28, 2006, and approved by the Board of Governors of the State University System, in the implementation of a land lease 38 39 for the development and operation of a community-university affiliated teaching hospital which will serve as the primary 40 41 teaching hospital for the regional campus of the University of 42 Miami Miller School of Medicine at Florida Atlantic University. All records and information in the possession of Boca 43 (2) 44 Raton Community Hospital, Inc., or a subsidiary thereof, in its capacity as lessee as defined in subsection (1) are confidential 45 and exempt from the provisions of s. 119.07(1) and s. 24(a), 46 47 Art. I of the State Constitution. This exemption does not apply 48 to any records or information that is solely related to the 49 undergraduate medical and graduate medical programs of the 50 University of Miami Miller School of Medicine at Florida 51 Atlantic University, which shall be public records unless made 52 confidential or exempt by law. (3) A meeting or portion of a meeting of the board of 53 54 directors of Boca Raton Community Hospital, Inc., or a subsidiary thereof, in its capacity as lessee as defined in 55 56 subsection (1), at which information is presented or discussed

85 development and operation of a community-university affiliated 86 teaching hospital be held confidential and exempt from public 87 records requirements in order for the teaching hospital to fulfill its mission in medical research and education and to 88 89 ensure that the lessee and its subsidiaries are not placed at a 90 disadvantage in a competitive health care environment. These 91 exemptions are necessary because these records contain information that, if disclosed, would adversely impact the 92 93 lessee or its subsidiaries in the competitive health care environment. Disclosure of such records and information would 94 place the lessee and its subsidiaries on an unequal footing in 95 the marketplace as compared with private health care providers 96 97 that are not required to disclose such confidential and exempt 98 information. The Legislature finds that the disclosure of such 99 confidential and exempt information would adversely impact the 100 lessee and its subsidiaries in fulfilling their mission of medical treatment, research, and education. The Legislature 101 further finds that it is a public necessity that meetings of the 102 103 board of directors of Boca Raton Community Hospital, Inc., or a subsidiary thereof, in its capacity as lessee be held exempt 104 105 from public meetings requirements in order to protect the 106 competitive interests of the lessee and to guarantee the ability 107 of the lessee to fulfill its medical research and teaching 108 mission for the benefit of the public. Consequently, the 109 Legislature finds that it is a public necessity that any records 110 generated during those meetings or portions of meetings of the 111 board of directors of Boca Raton Community Hospital, Inc., or a subsidiary thereof, in its capacity as lessee which have been 112 Page 4 of 5
