Section 1. Paragraph (d) of subsection (4) of section 119.071, Florida Statutes, is amended to read:

119.071 General exemptions from inspection or copying of public records.--

- (4) AGENCY PERSONNEL INFORMATION. --
- (d)1. The home addresses, telephone numbers, social security numbers, and photographs of active or former law enforcement personnel, including correctional and correctional probation officers, personnel of the Department of Children and Family Services whose duties include the investigation of abuse, neglect, exploitation, fraud, theft, or other criminal activities, personnel of the Department of Health whose duties are to support the investigation of child abuse or neglect, and personnel of the Department of Revenue or local governments whose responsibilities include revenue collection

and enforcement or child support enforcement; the home 2 addresses, telephone numbers, social security numbers, photographs, and places of employment of the spouses and 3 children of such personnel; and the names and locations of 4 schools and day care facilities attended by the children of 5 6 such personnel are exempt from s. 119.07(1). The home 7 addresses, telephone numbers, and photographs of firefighters 8 certified in compliance with s. 633.35; the home addresses, 9 telephone numbers, photographs, and places of employment of the spouses and children of such firefighters; and the names 10 and locations of schools and day care facilities attended by 11 12 the children of such firefighters are exempt from s. 13 119.07(1). The home addresses and telephone numbers of justices of the Supreme Court, district court of appeal 14 judges, circuit court judges, and county court judges; the 15 home addresses, telephone numbers, and places of employment of 16 17 the spouses and children of justices and judges; and the names 18 and locations of schools and day care facilities attended by the children of justices and judges are exempt from s. 19 119.07(1). The home addresses, telephone numbers, social 20 21 security numbers, and photographs of current or former state 22 attorneys, assistant state attorneys, statewide prosecutors, 23 or assistant statewide prosecutors; the home addresses, telephone numbers, social security numbers, photographs, and 2.4 places of employment of the spouses and children of current or 25 former state attorneys, assistant state attorneys, statewide 26 27 prosecutors, or assistant statewide prosecutors; and the names 2.8 and locations of schools and day care facilities attended by 29 the children of current or former state attorneys, assistant state attorneys, statewide prosecutors, or assistant statewide 30 31

prosecutors are exempt from s. 119.07(1) and s. 24(a), Art. I of the State Constitution.

- 2. The home addresses, telephone numbers, and photographs of current or former human resource, labor relations, or employee relations directors, assistant directors, managers, or assistant managers of any local government agency or water management district whose duties include hiring and firing employees, labor contract negotiation, administration, or other personnel-related duties; the names, home addresses, telephone numbers, and places of employment of the spouses and children of such personnel; and the names and locations of schools and day care facilities attended by the children of such personnel are exempt from s. 119.07(1) and s. 24(a), Art. I of the State Constitution.
- 3. The home addresses, telephone numbers, social security numbers, and photographs of current or former United States attorneys and assistant United States attorneys; the home addresses, telephone numbers, social security numbers, photographs, and places of employment of the spouses and children of current or former United States attorneys and assistant United States attorneys; and the names and locations of schools and day care facilities attended by the children of current or former United States attorneys and assistant United States attorneys are exempt from s. 119.07(1) and s. 24(a), Art. I of the State Constitution. This subparagraph is subject to the Open Government Sunset Review Act in accordance with s. 119.15 and shall stand repealed on October 2, 2009, unless reviewed and saved from repeal through reenactment by the Legislature.

- The home addresses, telephone numbers, social security numbers, and photographs of current or former judges of United States Courts of Appeal, United States district judges, and United States magistrate judges; the home addresses, telephone numbers, social security numbers, photographs, and places of employment of the spouses and children of current or former judges of United States Courts of Appeal, United States district judges, and United States magistrate judges; and the names and locations of schools and day care facilities attended by the children of current or former judges of United States Courts of Appeal, United States district judges, and United States magistrate judges are exempt from s. 119.07(1) and s. 24(a), Art. I of the State Constitution. This subparagraph is subject to the Open Government Sunset Review Act in accordance with s. 119.15 and shall stand repealed on October 2, 2009, unless reviewed and saved from repeal through reenactment by the Legislature.
- 5. The home addresses, telephone numbers, and photographs of current or former code enforcement officers; the names, home addresses, telephone numbers, and places of employment of the spouses and children of such personnel; and the names and locations of schools and day care facilities attended by the children of such personnel are exempt from s. 119.07(1) and s. 24(a), Art. I of the State Constitution.
- 6. The home addresses, telephone numbers, places of employment, and photographs of current or former guardians ad litem, as defined in s. 39.820, and the names, home addresses, telephone numbers, and places of employment of the spouses and children of such persons, are exempt from s. 119.07(1) and s. 24(a), Art. I of the State Constitution, if the guardian ad litem provides a written statement that the guardian ad litem

has made reasonable efforts to protect such information from being accessible through other means available to the public.

This subparagraph is subject to the Open Government Sunset Review Act in accordance with s. 119.15 and shall stand repealed on October 2, 2010, unless reviewed and saved from repeal through reenactment by the Legislature.

7. The home addresses, telephone numbers, and photographs of current or former juvenile probation officers, juvenile probation supervisors, detention superintendents, assistant detention superintendents, senior juvenile detention officers, juvenile detention officer supervisors, juvenile detention officers, house parents I and II, house parent supervisors, group treatment leaders, group treatment leader supervisors, rehabilitation therapists, and social services counselors of the Department of Juvenile Justice; the names, home addresses, telephone numbers, and places of employment of spouses and children of such personnel; and the names and locations of schools and day care facilities attended by the children of such personnel are exempt from s. 119.07(1) and s. 24(a), Art. is a public necessity. This exemption is justified because if 2 such information were not confidential, an emergency medical 3 technician or paramedic or a member or members of his or her 4 family could be harmed or threatened with harm by an 5 individual, or a family member of such individual, who was 6 provided emergency medical care which resulted in a negative 7 outcome. The exemption is further justified because emergency 8 medical technicians and paramedics are subject to the same 9 exposure as law enforcement officers and firefighters, both of 10 which are protected by an exemption from public records requirements for personal identifying and location information 11 12 pertaining to the law enforcement officers, firefighters, and 13 their families.
