SUMMARY ANALYSIS

CS/HB 1343 provides that the Department of Health (DOH) will promote health and wellness and disease prevention initiatives in addition to its other duties. It also renames the head of the department, "State Surgeon General."

The bill has no fiscal impact.

The bill provides an effective date of July 1, 2007.

FULL ANALYSIS

I. SUBSTANTIVE ANALYSIS

A. HOUSE PRINCIPLES ANALYSIS:

Provide limited government, Promote Personal Responsibility, Empower Families --- This bill emphasizes the role of DOH in promoting wellness and preventing disease among Floridians and their families. By providing health education and wellness information, citizens will be better able to achieve their own wellness goals and adopt healthier lifestyles for themselves and their families.

B. EFFECT OF PROPOSED CHANGES:

According to the National Alliance for Nutrition and Activity,¹

- Two-thirds of premature deaths in the U.S. are due to poor nutrition, physical inactivity and tobacco use.
- Over the last 25 years, obesity rates doubled among U.S. adults and children and tripled in teens.
- Poor diet and inactivity contribute significantly to four out of the six leading causes of death --heart disease, cancer, stroke, and diabetes.

Many of these deaths can be prevented and the quality of life enhanced for millions of people if they can be convinced to exercise regularly, eat nutritious foods, avoid tobacco, and control chronic diseases.

The designation of "Surgeon General" is used to identify the chief physician of the public health corps of a state or nation, and, as the Surgeon General of the United States, America's chief health educator.²

CS/HB 1343 provides an additional duty to DOH --- that the department will promote health and wellness and disease prevention initiatives. It renames the head of DOH "State Surgeon General" and directs the Division of Statutory Revision to make necessary conforming changes throughout the statute to reflect the name change.

The bill is effective July 1, 2007.

C. SECTION DIRECTORY:

Section 1: Amends s. 20.43, F. S.; provides for additional duty of DOH; designates head of DOH as State Surgeon General.

Section 2: Amends s. 381.0605, F.S.; conforms name.

Section 3: Directs the Division of Statutory Revision to change references to the head of DOH, to conform with the State Surgeon General title as provided in the bill.

Section 4: Provides an effective date of July 1, 2007.

- Thousands of Florida's children have early stages of diabetes without diagnosis, and they will face serious health problems by the time they are 30.
- Florida faces issues of tobacco and substance abuse, obesity, health disparities and other preventable diseases.
- We must be aggressive in tackling these problems and we must work together - as a Government and as a people - to improve the lifelong health of all Floridians.
- To do so, Florida needs a strong advocate and leading voice for public health promotion and disease prevention efforts.
- House Bill 1343 proposes to refocus the Department of Health to be headed by the State Surgeon General as a leading advocate for these issues.
- Florida's State Surgeon General will also work to build partnerships between Floridians, public and private institutions, communities and schools to forward important health initiatives.
- Florida will become the second state in the nation to name a State Surgeon General and through this we will demonstrate our commitment to public health and disease prevention. (Michigan is the only other state with a State Surgeon General)

IV. AMENDMENTS/COUNCIL SUBSTITUTE CHANGES

On March 20, 2007, the Health Innovation Committee adopted one amendment. The amendment:

- Revises the purposes of the Department of Health to include the promotion of health and wellness and disease prevention initiatives, including promotion of immunization practices in accordance with the Advisory Committee on Immunization Practices of the Centers for Disease Control and Prevention of the United States Department of Health and Human Services.
- Revises the purposes of the Department of Health to include that the department provide leadership, in cooperation with medical schools and the health care community, in assessing and addressing the adequacy of Florida's physician and health professional workforce to address the state's health care access needs.

The bill was reported favorable with one amendment.

On March 27, 2007, the Health Care Council adopted one strike-all amendment. The amendment:

- Renames the head of the Department of Health as the State Surgeon General and provides that the State Surgeon General serves as the leading voice on wellness and disease prevention efforts, including healthy lifestyles, immunization practices, health literacy, and the assessment and promotion of the physician and health care workforce to meet the Florida's health care needs.
- Includes a directive to the Division of Statutory Revision to prepare a reviser's bill for introduction at a subsequent legislative session to reflect revisions to the name change reflected in the bill.

The bill was reported favorable as a council substitute.

The staff analysis reflects CS/HB1343.
