6 (h) One-quarter of the moneys deposited into the Pari-
7 mutuel Wagering Trust Fund pursuant to paragraph (g) shall, by
8 October 1 of each year, be distributed to the local government
9 that approved the cardroom under subsection (16) counties in
10 ~~which the cardrooms are located~~; however, if two or more pari-
11 mutuel racetracks are located within the same incorporated
12 municipality, the cardroom funds shall be distributed to the
13 municipality. If a pari-mutuel facility is situated in such a
14 manner that it is located in more than one county, the site of
15 the cardroom facility shall determine the location for purposes
16 of disbursement of tax revenues under this paragraph. The
