22	an annual basis thereafter, a report on the status of
23	competition in the telecommunications industry and a detailed
24	exposition of the following:

26	telecommunications competition on the continued availability
27	of universal service.
28	2.(b) The ability of competitive providers to make
29	functionally equivalent local exchange services available to
30	both residential and business customers at competitive rates,

3.<del>(c)</del> The ability of consumers to obtain functionally 2 equivalent services at comparable rates, terms, and conditions. 3 4 4.(d) The overall impact of price regulation on the maintenance of reasonably affordable and reliable high-quality 5 telecommunications services. 7 5.(e) What additional services, if any, should be 8 included in the definition of basic local telecommunications services, taking into account advances in technology and 9 10 market demand. 6.<del>(f)</del> Any other information and recommendations which 11 12 may be in the public interest. 13 (b) The commission shall make an annual request to providers of local exchange telecommunications services by 14 March 1, 2008, and on or before March 1 of each year 15 thereafter, for the data it requires to complete the report. 16 17 (2) In lieu of any other information required by the 18 commission to complete the report under subsection (1), a provider of local exchange telecommunications services shall 19 file the following with the commission on or before April 15, 2.0 21 2008, and on or before April 15 each year thereafter: 22 (a) A copy of the FCC Form 477 filed with the Federal 23 Communications Commission, which must identify Florida-specific access line data; or 2.4 (b) A response to the annual data request of the 2.5 commission issued pursuant to paragraph (1)(b). 26 27 (3) The Office of Public Counsel is also directed 2.8 to submit a report on competition in the telecommunications industry and on how the price regulation provisions of s. 29 30 364.051 have benefited the ratepayers and consumers of this
