Senate Amendment (with directory and title amendments)

On page 3....., between lines 15 and 16....,

insert: (4) AUTHORITY OF DIVISION.--The Division of Pari-mutuel Wagering of the Department of Business and Professional Regulation shall administer this section and regulate the operation of cardrooms under this section and the rules adopted pursuant thereto, and is hereby authorized to:

(a)1. Adopt rules, including, but not limited to: the issuance of cardroom and employee licenses for cardroom operations; the operation of a cardroom; recordkeeping and reporting requirements; and the collection of all fees and taxes imposed by this section.

2. Adopt rules for the operation of high stakes poker tournaments, including, but not limited to: maximum buy in amounts, number of players, amount of betting units, and payout scales.

(b) Conduct investigations and monitor the operation

2 (c) Review the books, accounts, and records of any
3 current or former cardroom operator.

4 (d) Suspend or revoke any license or permit, after
5 hearing, for any violation of the provisions of this section

7 (e) Take testimony, issue summons and subpoenas for
8 any witness, and issue subpoenas duces tecum in connection
9 with any matter within its jurisdiction.

10 (f) Monitor and ensure the proper collection of taxes
11 and fees imposed by this section. Permitholder internal
12 controls are mandated to ensure no compromise of state funds.
13 To that end, a roaming division auditor will monitor and
14 verify the cash flow and accounting of cardroom revenue for
15 any given operating day.
