Subsection (2) of section 849.086, Florida 13 Statutes, is amended, present subsections (9) through (17) of that subsection are redesignated as subsections (11) through 14 (19), respectively, and new subsections (9) and (10) are added 15 to that section, to read: 16 849.086 Cardrooms authorized.--(2) DEFINITIONS.--As used in this section: 18 (a) "Authorized game" means a game or series of games 19 of poker which are played in a nonbanking manner. 20 21 (b) "Banking game" means a game in which the house is 22 a participant in the game, taking on players, paying winners, 23 and collecting from losers or in which the cardroom establishes a bank against which participants play. 2.4 (c) "Cardroom" means a facility where authorized card 25 games are played for money or anything of value and to which 26 27 the public is invited to participate in such games and charged 2.8 a fee for participation by the operator of such facility. Authorized games and cardrooms do not constitute casino gaming 29 30 operations. 31

- (d) "Cardroom management company" means any individual not an employee of the cardroom operator, any proprietorship, partnership, corporation, or other entity that enters into an agreement with a cardroom operator to manage, operate, or otherwise control the daily operation of a cardroom.
- (e) "Cardroom distributor" means any business that distributes cardroom paraphernalia such as card tables, betting chips, chip holders, drop boxes, banking supplies, playing cards, card shufflers, and other associated equipment to authorized cardrooms.
- (f) "Cardroom operator" means a licensed pari-mutuel permitholder which holds a valid permit and license issued by the division pursuant to chapter 550 and which also holds a valid cardroom license issued by the division pursuant to this section which authorizes such person to operate a cardroom and to conduct authorized games in such cardroom.
- (g) "Division" means the Division of Pari-mutuel Wagering of the Department of Business and Professional Regulation.
- (h) "Dominoes" means flat rectangular blocks the faces of which are divided into two equal parts that are blank or include from one to six dots arranged in a pattern.
- (i) "High-stakes dominoes" means a game of dominoes
  which is played using a set of 28 dominoes and without limits
  on the amount wagered in any game or series of games or
  without limits on the rounds of betting.
- (j)(h) "Gross receipts" means the total amount of
  money received by a cardroom from any person for participation
  in authorized games.
- 30 (k) "High-stakes poker" means a game of poker which is
  31 played without limits on the amount wagered in any game or

series of games or without limits on the rounds of betting established in this section.

 $\underline{\text{(1)}}$  "House" means the cardroom operator and all employees of the cardroom operator.

(m)(j) "Net proceeds" means the total amount of gross receipts received by a cardroom operator from cardroom operations less direct operating expenses related to cardroom operations, including labor costs, admission taxes only if a separate admission fee is charged for entry to the cardroom facility, gross receipts taxes imposed on cardroom operators by this section, the annual cardroom license fees imposed by this section on each table operated at a cardroom, and reasonable promotional costs excluding officer and director compensation, interest on capital debt, legal fees, real estate taxes, bad debts, contributions or donations, or overhead and depreciation expenses not directly related to the operation of the cardrooms.

(n)(k) "Rake" means a set fee or percentage of the pot assessed by a cardroom operator for providing the services of a dealer, table, or location for playing the authorized game.

(9) HIGH-STAKES POKER TOURNAMENTS.--A cardroom operator may host a high-stakes poker tournament twice each year for 1 week at a pari-mutuel facility that is authorized to operate cardrooms during the hours that the pari-mutuel facility is open to conduct business. Such a tournament may be conducted only once in any 6-month period.

(10) HIGH-STAKES DOMINOES TOURNAMENTS.--A cardroom operator may host a high-stakes dominoes tournament twice each year for 1 week at a pari-mutual facility that is authorized to operate cardrooms during the hours that the pari-mutual

1	facility is open to conduct business. Such a tournament may be
2	conducted only once in any 6-month period.
3	Section 2. This act shall take effect July 1, 2007.
