It is the finding of the Legislature that 10 it is a public necessity that records and information in the possession of Boca Raton Community Hospital, Inc., or a 11 subsidiary thereof, in its capacity as the lessee of land on 12 the Boca Raton campus of Florida Atlantic University for the 13 development and operation of a community-university affiliated 14 15 teaching hospital be held confidential and exempt from public-records requirements in order for the teaching hospital 16 to fulfill its mission in medical research and education and 17 to ensure that the lessee and its subsidiaries are not placed 18 19 at a disadvantage in a competitive health care environment. 20 These exemptions are necessary because these records contain information that, if disclosed, would adversely affect the 21 22 lessee or its subsidiaries in the competitive health care environment. Disclosure of such records and information would 23 2.4 place the lessee and its subsidiaries on an unequal footing in the marketplace as compared with private health care providers 2.5 that are not required to disclose such confidential and exempt 26 information. The Legislature finds that the disclosure of such 27 confidential and exempt information would adversely affect the 28 29 lessee and its subsidiaries in fulfilling their mission of medical treatment, research, and education.
