 7 Be It Enacted by the Legislature of the State of Florida:

 9 Section 1. Paragraph (a) of subsection (2) of section
 10 282.1095, Florida Statutes, is amended to read:

11 282.1095 State agency law enforcement radio system and
 12 interoperability network.--

13 (2) (a) The Joint Task Force on State Agency Law
 14 Enforcement Communications shall consist of 15 ~~eight~~ members, as
 15 follows:

16 1. A representative of the Division of Alcoholic Beverages
 17 and Tobacco of the Department of Business and Professional
 18 Regulation who shall be appointed by the secretary of the
 19 department.

20 2. A representative of the Division of Florida Highway
 21 Patrol of the Department of Highway Safety and Motor Vehicles
 22 who shall be appointed by the executive director of the
 23 department.

24 3. A representative of the Department of Law Enforcement
 25 who shall be appointed by the executive director of the
 26 department.

27 4. A representative of the Fish and Wildlife Conservation
 28 Commission who shall be appointed by the executive director of
 29 the commission.

30 5. A representative of the Division of Law Enforcement of
 31 the Department of Environmental Protection who shall be
 32 appointed by the secretary of the department.

33 6. A representative of the Department of Corrections who
 34 shall be appointed by the secretary of the department.

35 7. A representative of the Division of State Fire Marshal
 36 of the Department of Financial Services who shall be appointed
 37 by the State Fire Marshal.

38 8. A representative of the Department of Transportation
 39 who shall be appointed by the secretary of the department.

40 9. A representative of the Division of Emergency
 41 Management who shall be appointed by the director of the
 42 division.

43 10. A representative of the Florida Police Chiefs
 44 Association who shall be appointed by the president of the
 45 association.

46 11. A representative of the Florida Sheriffs Association
 47 who shall be appointed by the president of the association.

48 12. A representative of the Florida Fire Chiefs
 49 Association who shall be appointed by the president of the
 50 association.

51 13. A representative of the Florida Police Benevolent
 52 Association who shall be appointed by the president of the
 53 association.

54 14. A representative of the Florida Fraternal Order of
55 Police who shall be appointed by the president of the order.

56 15. A representative of the Florida Professional
57 Firefighters Association who shall be appointed by the president
58 of the association.

59 Section 2. This act shall take effect July 1, 2007.
