1 WHEREAS, during this time Martin Lee Anderson complained of breathing difficulties but was not given the 2 3 proper medical attention, and 4 WHEREAS, Martin Lee Anderson's failed attempts to stand up resulted in being restrained to a wall by the 5 employees/guards, and given ammonia tablets, and 6 7 WHEREAS, the entire matter was captured on security surveillance video camera and was released to the public only 8 after the Miami Herald and CNN sued to have said video 9 released, and 10 11 WHEREAS, the employees/guards continued to hold such tablets over Martin Lee Anderson's airways while covering his 12 13 mouth until he became unresponsive, and WHEREAS, after a considerable amount of time the 14 15 employees/guards placed a call to 911 requesting an ambulance 16 and Martin Lee Anderson was taken to Sacred Heart Hospital where he was pronounced dead at 1:53 a.m. on January 6, 2006, 17 18 and 19 WHEREAS, the death of Martin Lee Anderson was caused by suffocation brought on by the manual occlusion of the mouth in 20 concert with the forced inhalation of ammonia fumes, and 21 22 WHEREAS, the employees/guards of the boot camp are directly responsible for the administration of the ammonia 23 24 pills and the covering of Martin Lee Anderson's nose and mouth, which contributed to the suffocation, and 25 WHEREAS, the actions of the employees/guards violated 26 the customary and standards protocol and procedures, effective 27 June 21, 2004, with respect to physical restraints and 28 29 interactions with minor offenders at facilities of the Department of Juvenile Justice which does not permit the use 30 of pressure point maneuvers, and 31 4 s2968d-ja12-j01 4:51 PM 04/20/07
