Section 4. Subsection (1) of section 175.101, Florida Statutes, is amended to read:

175.101 State excise tax on property insurance premiums authorized; procedure.--For any municipality, special fire control district, chapter plan, local law municipality, local law special fire control district, or local law plan under this chapter:

(1) Each municipality or special fire control district in this state described and classified in s. 175.041, having a lawfully established firefighters' pension trust fund or municipal fund or special fire control district fund, by whatever name known, providing pension benefits to firefighters 708121

17 as provided under this chapter, may assess and impose on every 18 insurance company, corporation, or other insurer now engaged in or carrying on, or who shall hereinafter engage in or carry on, 19 the business of property insurance as shown by the records of 20 the Office of Insurance Regulation of the Financial Services 21 22 Commission an excise tax in addition to any lawful license or excise tax now levied by each of the municipalities or special 23 fire control districts, respectively, amounting to 1.85 percent 24 25 of the gross amount of receipts of premiums from policyholders on all premiums collected on property insurance policies 26 covering property within the corporate limits of such 27 municipalities or within the legally defined boundaries of 28 29 special fire control districts, respectively. Whenever the boundaries of a special fire control district that has lawfully 30 established a firefighters' pension trust fund encompass a 31 portion of the corporate territory of a municipality that has 32 also lawfully established a firefighters' pension trust fund, 33 34 that portion of the tax receipts attributable to insurance policies covering property situated both within the municipality 35 and the special fire control district shall be given to the fire 36 service provider. For the purpose of this section, the 37 boundaries of a special fire control district shall be deemed to 38 include an area that has been annexed until the completion of 39 the 4-year period provided for in s. 171.093(4), or other 40 41 agreed-upon extension, or the termination of an interlocal agreement executed pursuant to s. 171.093(3). to this chapter shall be distributed to the municipality or special fire control district according to the location of the insured property.

This section also applies to any municipality consisting of a single consolidated government which is made up of a former county and one or more municipalities, consolidated pursuant to the authority in s. 3 or s. 6(e), Art. VIII of the State Constitution, and to property insurance policies covering property within the boundaries of the consolidated government, regardless of whether the properties are located within one or more separately incorporated areas within the consolidated government, provided the properties are being provided fire protection services by the consolidated government. This section also applies to any municipality, as provided in s. 175.041(3)(c), which has entered into an interlocal agreement to receive fire protection services from another municipality participating under this chapter. The excise tax may be levied on all premiums collected on property insurance policies covering property located within the corporate limits of the municipality receiving the fire protection services, but will be available for distribution to the municipality providing the fire protection services.
