For the purposes of this 27 paragraph, "completion and satisfaction of all sentences" 2.8 occurs when a person is released from incarceration upon expiration of sentence and has achieved or completed all other 29 nonmonetary terms and conditions of the sentence or subsequent 30 supervision or, if the person has not been incarcerated for 31

The applicant's name. 20 21 2. The applicant's legal residence address. 22 3. The applicant's date of birth. 23 4. A mark in the checkbox affirming that the applicant is a citizen of the United States. 24 5.a. The applicant's current and valid Florida 25 driver's license number or the identification number from a 26 27 Florida identification card issued under s. 322.051, or 2.8 b. If the applicant has not been issued a current and valid Florida driver's license or a Florida identification 29 30 card, the last four digits of the applicant's social security number. 31

1 2 In case an applicant has not been issued a current and valid Florida driver's license, Florida identification card, or 3 social security number, the applicant shall affirm this fact 4 in the manner prescribed in the uniform statewide voter 5 6 registration application. 7 6. A mark in the checkbox affirming that the applicant 8 has not been convicted of a felony or that, if convicted, has 9 had his or her voting civil rights restored. 10 7. A mark in the checkbox affirming that the applicant has not been adjudicated mentally incapacitated with respect 11 12 to voting or that, if so adjudicated, has had his or her right 13 to vote restored. 8. The original signature or a digital signature 14 transmitted by the Department of Highway Safety and Motor 15 Vehicles of the applicant swearing or affirming under the 16 17 penalty for false swearing pursuant to s. 104.011 that the 18 information contained in the registration application is true and subscribing to the oath required by s. 3, Art. VI of the 19 State Constitution and s. 97.051. 20 21 Section 5. This act shall take effect on the effective 22 date of Senate Joint Resolution ____ or another amendment to 23 the State Constitution which authorizes, or removes 2.4 impediments to, enactment of this act by the Legislature. 25 26 27 SENATE SUMMARY 2.8 Creates the "Citizens' Empowerment Act." Provides that a convicted felon who is incarcerated or is on probation, parole, or community control may not vote. Provides for restoration of that right 1 year after completion of the 29 30 sentence, unless automatic restoration is objected to by a majority of the Board of Executive Clemency. 31
